

Under clause 2.7 of the Victorian Electricity Supply Industry Tariff Order, if a party to a particular type of contract (called a "vesting contract") gives a notice to the Regulator-General under the contract in relation to a particular type of event (called a "generator force majeure event"), the Regulator-General must determine (amongst other things):

- if the generator force majeure event specified in the notice occurred or is continuing; and
- if so, the total loss incurred by the electricity retailer party to the contract through the consequent granting of relief to the electricity generator party to the contract (with that loss to then be passed through by the retailer to its franchise customers).

The Regulator-General received on 18 May 2000 six notices signed for and on behalf of Gippsland Power Pty Ltd. In essence, each notice claimed that there had been a generator force majeure event in relation to Loy Yang B generating plant.

In relation to each such notice, the Regulator-General has determined that the force majeure event specified in it did not occur and is not continuing.

The effect of each such determination is that Gippsland Power Pty Ltd is not granted relief under the relevant contracts in respect of the event specified in the notices, with no electricity retailer party to such a contract incurring loss through the granting of such relief. Hence, as no retailer has incurred such a loss, no amount is to be passed through by the retailer to its franchise customers.

Each determination so made by the Regulator-General takes effect on and from the date on which notice of its making is published in the Government Gazette.

been prepared in relation to the Wildlife (Whales) (Logans Beach) Regulations 2000.

The objective of the proposed Regulations is to:

• Protect Southern Right Whales while they are resident in the calving grounds at Logans Beach, Warrnambool.

These regulations will protect the long-term conservation of Southern Right Whales, which are listed as endangered in Victoria under the **Wildlife Act 1975**, while they are present at Logans Beach, Victoria.

The RIS discusses one possible alternative to the proposed Regulations: increasing the minimum prescribed distance for boats approaching whales to 300 metres at Logans Beach. The proposed regulations were considered the best means of achieving the objective as they provide total protection from disturbance from boats while they are at Logans Beach.

The proposed regulations will prohibit boating in an area of approximately six square kilometres. The boating exclusion zone would extend from the eastern side of the Hopkins River mouth to Gauls Cave, approximately 5 kilometres to the east and one nautical mile offshore. Although the dates specified in the regulations are from 1 June to 31 October each year, the exclusion will only apply for the time the whales are in residence at Logans Beach so that the impact on recreational and commercial activities will be minimal. If the whales are not present between the prescribed dates (i.e. not arrived by 1 June or finally departed before 31 October), the Minister will be able to authorise boating in Logans Beach via notice in the Government Gazette.

CONTROL OF WEAPONS REGULATIONS 1990

Exemption of Person from Provisions of Act Order in Council

The Governor in Council under Sections 5 of the **Control of Weapons Act 1990** grants the following exemption from the provisions of Section 5(1) of that Act:

- Mr Colin James BRENNAN of Unit 1/25 Stanley Street, Black Rock 3193 to enable him to import, manufacture, possess, purchase and carry daggers and swordsticks as a bona-fide collector and to sell to persons authorised when:
 - bringing into Victoria or causing to be brought into Victoria, manufacturing, possessing, purchasing and carrying daggers and swordsticks and selling to

persons authorised, subject to the following conditions:

- a) the exemption holder is to provide, in writing, to the Chief Commissioner of Police details of any daggers or swordsticks imported, manufactured, purchased or disposed of within 14 days of the import, manufacture, purchase or disposal.
- b) the exemption holder must ensure that all swordsticks and daggers are stored in a manner approved by the Chief Commissioner of Police.
- c) the exemption holder will be liable to the penalty set out in Section 5(1) of the Act if the exemption holder fails to comply with any conditions set out in the exemption.
