## Gas Industry Act 1994

### GAS CONTESTABILITY TIMETABLE

#### Notice of Contestability of Non-Franchise Customers

For the purposes of licences to sell gas ("Licences") issued by the ORG pursuant to the **Gas Industry Act 1994** (the "Act"), I, Candy Broad, Minister, hereby specify that all persons who are non-franchise customers within the meaning of Section 6B(1)(d) of the Act (other than Excluded Customers) are customers to whom the licencees can sell gas pursuant to clause 2(c) of their respective Licences from 1 September 2000 (or such later date as specified in a Notice by the Minister for this purpose in the Gazette).

For the purposes of this Notice:

- (a) a person is an "Excluded Customer" in relation to a supply of gas from a supply point if the gas is supplied from a supply point on or after 1 September 2000 and –
  - (i) the person had purchased not more than 10,000 GJ of gas from that supply point, or an ancillary supply point, during the period of 12 months immediately preceding 1 September 2000 or the commencement of the supply, whichever is the later; or
  - (ii) the supply point is new and the ORG is satisfied on reasonable grounds that the person will purchase not more than 10,000 GJ of gas from that supply point within a period of 12 months during the 3 years next following 1 September 2000 or the commencement of the supply, whichever is the later; and
- (b) words and expressions that are defined in the Act and not in this Notice and that are used in this Notice have the same meaning in this Notice as in the Act.

##### Amendment C21

The Minister for Planning has approved Amendment C21 to the Brimbank Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment introduces a Business 3 zone with a Development Plan Overlay and an Airport Environs Overlay on former Commonwealth land generally bounded by Keilor Park Drive, Spence Street, Swan Street and Harricks Road, Keilor Park.
