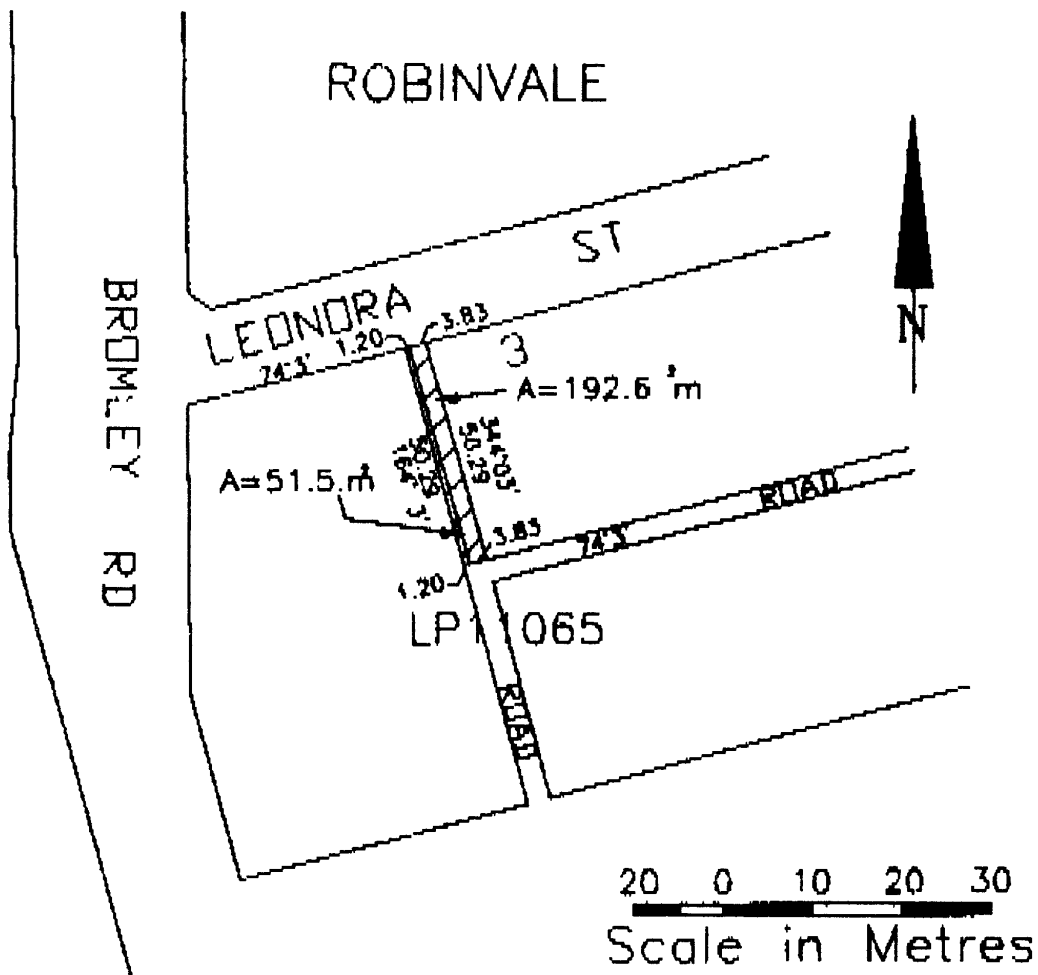

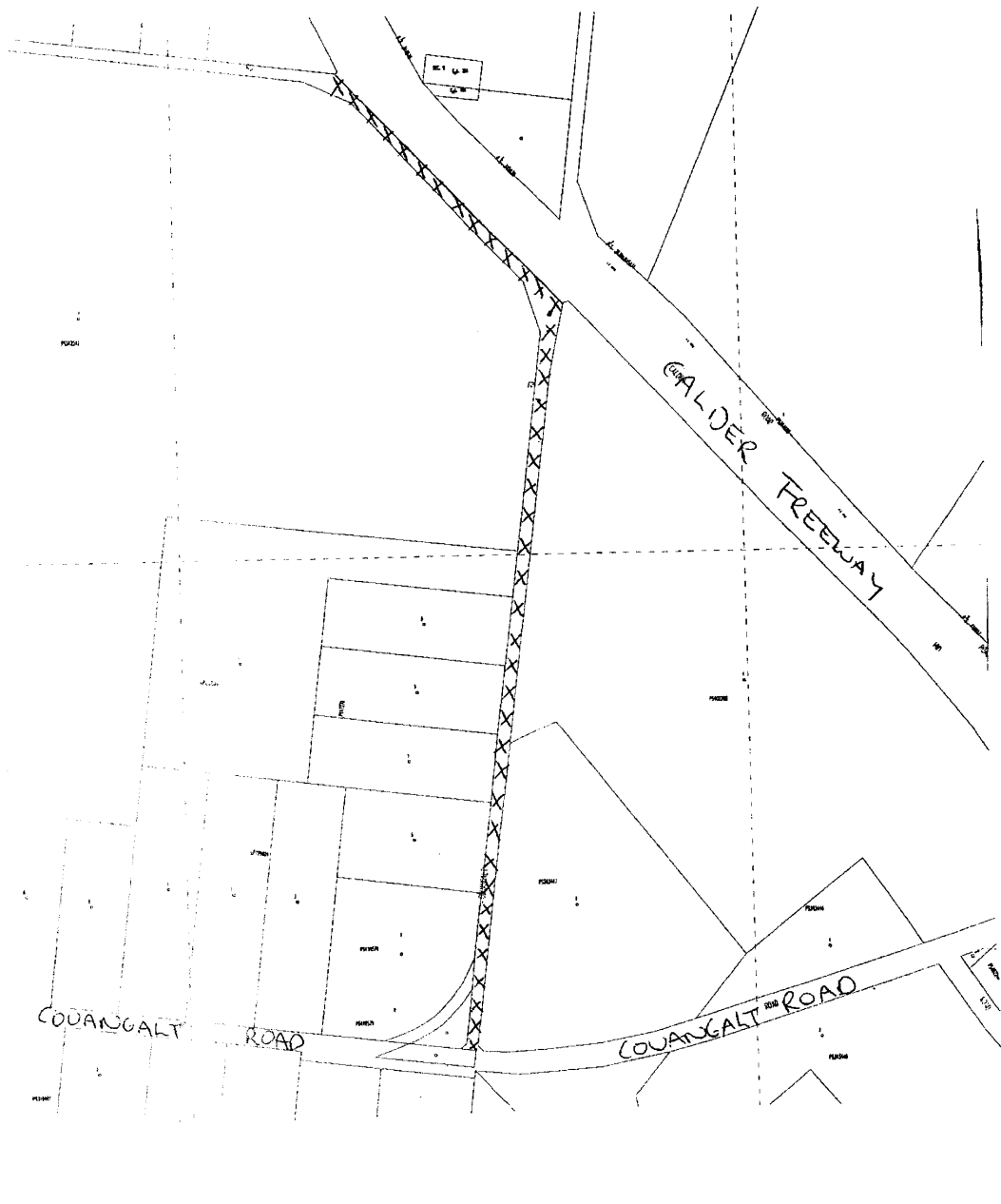

Council recently undertook its public consultation process, inviting residents to forward a submission for the naming/re-naming of roads throughout the Shire as identified through the rural re-numbering program.

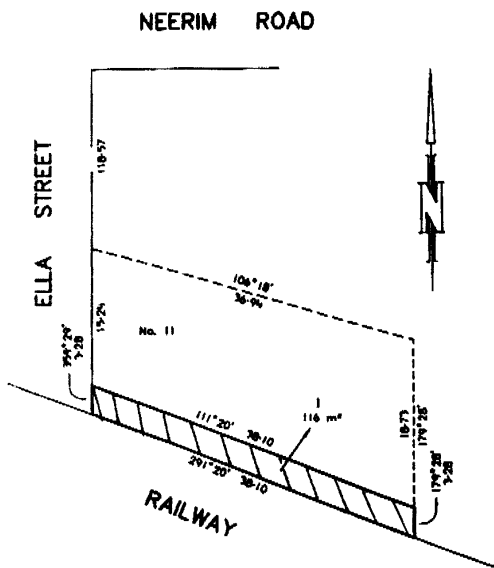

The City of Glen Eira has prepared Amendment No. C10 to the Glen Eira Planning Scheme.

Planning Scheme Amendment

The Amendment proposes to rezone the land from an Industrial 3 Zone to partly a Residential 1 Zone and partly Public Park and Recreation

Zone, and apply the Environmental Audit Overlay to the whole of the land.

Planning Application

The application is for a permit to subdivide the land into 24 lots – 23 lots being larger than 500m<sup>2</sup> and one large lot of approximately 9400m<sup>2</sup> which has frontage to North Road. The permit application is also for the development of 34 double storey dwellings on this larger lot. Part of the land is also to be transferred to Council for incorporation into the adjoining park to the south.

The person who requested the amendment and the application for permit is: Darnley Developments Pty Ltd.

- Removing banded morwong from Ocean Access and Rock Lobster Fishery Access Licences
- Removing the capacity for Bay and Inlet Fishery Access Licence Holders to specify an operator on their licence
- Closing the Anderson's Inlet and Shallow Inlet fisheries
- Creating gear restrictions on Western Port/Port Phillip Bay Fishery Access Licences for school and gummy shark
- Creating a levy and new class of licence for Aquaculture (Crown Land) Licence holders who culture bivalve shellfish. This levy introduces cost recovery for one third of the costs of administering the shellfish quality assurance program.

The regulatory impact statement (RIS) provides some possible alternatives to the proposed Regulations. These include a complete closure of the banded morwong fishery, banded morwong catch limit restrictions, further Bay and Inlet licence buy-back, imposition of a total allowable catch for school and gummy shark and a voluntary shellfish quality assurance program for bivalve shellfish farmers.
