  - Remains in effective voice or hand control of the dog so as to be able to promptly bring the dog under effective control by placing the dog on a chain, cord or leash if that becomes necessary; and
  - Does not allow the dog to rush, worry, chase, bite, or threaten any person or animal.

If the dog is off a chain, cord or leash in a Designated Reserve, the dog must be brought under effective control of the owner by means of a chain, cord or leash if the dog is within 20 metres of:

  - The principal location of an organised sporting event or the practising thereof;
  - Children's play equipment area;
  - The principal location of an organised public meeting; or
  - A permanent barbeque or picnic area.

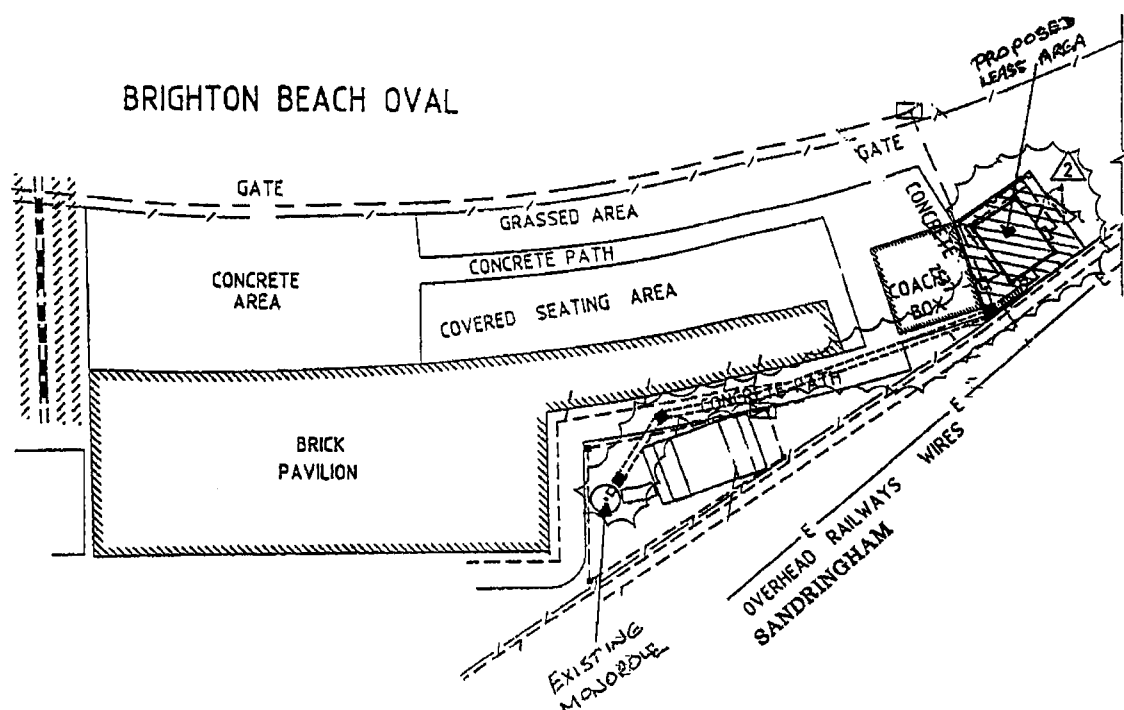

Exemptions for Disabled Riders of Bicycles to  
Ride on the Footpath

Subrule 250(1) of the Road Rules – Victoria, published as Government Gazette P2 of 1999 on 28 October 1999, and incorporated by reference into the Road Safety (Road Rules) Regulations 1999, makes it an offence for the rider of a bicycle who is 12 years old or older to ride on a footpath. Subrule 250(2) provides that subrule (1) does not apply to a rider in the circumstances specified by the Roads Corporation by notice published in the Government Gazette.

**1. Title**

These Regulations may be cited as the Caulfield Racecourse Reserve (Amendment) Regulations 2000.

**2. Objective**

For the admission of each person to all of the first, fourth and sixth divisions on other race days	12.00
For the admission to the eighth division of every motor vehicle (or \$50.00 per annum)	2.00

The Committee of the Victoria Amateur Turf Club, or any person duly authorised in writing by that Committee, may exempt any person wholly or partially from the payment of all or any of such charges or may reduce the same from time to time, and furthermore, the Club may levy such charges as it determines from time to time for access to reserved seats and private or corporate suites.

**(Admission and Access)**

Members of the Victoria Amateur Turf Club and Holders of Members' visitors' passes, upon production of their badges or passes, shall be admitted to any part of the said divisions with the exception of the third and seventh divisions without payment of any of the above charges for admission.
