





The road is to be sold subject to the right, power or interest held by South East Water Limited, in the road in connection with any sewers, drains, or pipes under the control of that authority in or near the road.



GREATER SHEPPARTON CITY COUNCIL Proposed Local Law No. 2

Consumption of Liquor in Public Places

Notice is hereby given that the Greater Shepparton City Council proposes to make Local Law No. 2 for the purpose of:

- (a) regulating and controlling the consumption of liquor and possession of liquor other than in a sealed container on a road, in or at a public place, in or on a stationary vehicle and on vacant private land; and
- (b) preventing behaviour which constitutes or may constitute a nuisance, or may be detrimental to health or safety or affects the enjoyment of public and other places; and





CONTROL OF WEAPONS REGULATIONS 2000

Notice is given of the availability of the proposed Control of Weapons Regulations 2000 and Regulatory Impact Statement (RIS) for public comment.

The objectives of the proposed Regulations are to reduce risks posed to public safety by prohibiting certain non-firearm weapons and reducing their general availability to the public, and to comply with the requirements, of the Control of Weapons Act 1990.

The proposed Regulations address a number of issues, including the:

- Proposed application fees for approvals to import, manufacture, sell, purchase, display or advertise for sale, possess, use or carry prohibited weapons;
- Recording requirements for sales of prohibited weapons;
- Proof of identity requirements necessary for

the legitimate purchase of prohibited weapons;

- Prescription of prohibited weapons:
- Prescription as controlled weapons, weapons that, although designed for a legitimate purpose, pose significant risks to the public if they are misused; and
- Prescription of garments or items as body armour

The proposed Regulations will have several major benefits. They will: ensure that a range of weapons whose purpose is exclusively offensive is prohibited in Victoria; reduce the risk of crime and injury involving these types of non-firearm weapons; and, allow the Government and Victoria Police to recover some of the costs of processing applications for approvals to possess prohibited weapons.

The RIS examines alternatives to the proposed Regulations. The RIS concludes that the proposed Regulations will generate the greatest benefits for the Victorian community.






