Road Transport (Dangerous Goods) Act 1995 ROAD TRANSPORT REFORM (DANGEROUS GOODS) ACT 1995 OF THE COMMONWEALTH

Appointment of Authorised Officers

The Victorian WorkCover Authority, a Competent Authority within the meaning of section 13 of **Road Transport Reform (Dangerous Goods) Act 1995** of the Commonwealth, applying as a law of Victoria by virtue of section 5 of the **Road Transport (Dangerous Goods) Act 1995**, under section 14 of the **Road Transport Reform (Dangerous Goods) Act 1995** of the Commonwealth, similarly applying as a law of Victoria, appoints the people named in the Schedule hereto, to be authorised officers.

The appointment of each person named in the Schedule hereto to be an authorised officer is subject to the restriction that the power to serve an infringement notice under regulation 21.1 of the Road Transport Reform (Dangerous Goods) Regulations of the Commonwealth is not exercisable by that officer.
