Rules of the Game — Baccarat

By this notice, the Victorian Casino and Gaming Authority **amends** the Rules in respect of the game "Baccarat"¹ as set out in the Schedule.

This notice operates with effect from 4.00am on 11 September 2000.

Schedule

1. Definitions for Insurance/No. 6

(1) **Insert**, at the end of rule 1.1.12

'Crown Baccarat may also offer an Insurance/No. 6 wager where winning wagers are paid at odds of 2 to 1.'.

- (2) **Insert**, following rule 1.1.13
 - '1.1.14 "Insurance/No. 6" means a wager that may be placed when the first two cards on the banker's hand total 6 and the player's hand must draw. The wager will lose when the banker wins with a total of 6 and win on all other outcomes. Players may only place an Insurance/No. 6 wager for an amount not exceeding their original player or banker wager for that hand. Insurance/No. 6 wagers shall be made before the commencement of the subsequent deal and will be placed in the space provided on the table layout.'
- 2. New wager type "Insurance No. 6"

Insert, after rule 5.6.3 —

5.6.4 Insurance/No. 6 where the version of Baccarat in play is Crown Baccarat'.

3. Minimum and maximum table differential

- (1) In rule 6.2, for "table differential" **substitute** "maximum and minimum table differential".
- (2) In rule 6.3, for "table differential" **substitute** "minimum table differential".
- (3) For rules 6.4-6.7 (both inclusive), substitute
 - ^{6.4} Where the version of play is Traditional Baccarat a player may place a wager that exceeds the minimum table differential provided that an additional commission is paid. The additional commission is payable on the amount of the wager exceeding the minimum table differential on both winning player and banker wagers. Wagers may not exceed the maximum table differential.

- 6.4.1 A winning wager on the banker's hand that exceeds the minimum table differential will be paid at odds of 1 to 1 less 5% commission for the total wager plus an additional 2.5% commission on all amounts in excess of the minimum table differential.
- 6.4.2 A winning wager on the player's hand that exceeds the minimum table differential will be paid at odds of 1 to 1 less 2.5% commission on all amounts in excess of the minimum table differential.
- 6.5 Minimum and maximum wagers which differ from those displayed on the table notice may be agreed for individual players and in such cases, the position occupied by the player shall be denoted by a distinctive marker stating "higher limit".
- 6.6 Wagers below the minimum shall be paid or collected after the result and the owner of the wager shall be advised that further wagers under the minimum shall be returned regardless of the result.
- 6.7 Wagers above the maximum shall be paid or collected to the maximum.
- 6.8 A Casino Supervisor may alter the limits on a gaming table at any time except that a minimum wager can only be changed to a higher minimum if a sign showing the proposed new minimum has been displayed at the table for at least 20 minutes before the time of the proposed change.'.

4. Rule clarification — no more bets

For rule 8.1.1.1, substitute —

'8.1.1.1 shall announce that no more bets are to be placed;'.

5. Settlement of Insurance/No. 6

- (1) Before the end of rule 11.1.1, insert 'except as authorised under the conditions of rule 6.4'.
- (2) Before the end of rule 11.1.2, insert 'except as authorised under the conditions of rule 6.4'.
- (3) For rules 11.1.3-11.1.4 (both inclusive), substitute
 - '11.1.3 Where the version of Baccarat being played is Crown Baccarat winning wagers on Insurance/No. 6 shall be paid at odds of 2 to 1.
 - 11.1.4 Wagers on a tie shall be paid at odds of 8 to 1 if the point count of the player's hand and the banker's hand is equal.
 - 11.1.5 The commission shall be collected from a player at the time the winning payout is made, but for seated players only, it may be deferred to a later time.
 - 11.1.5.1 Deferred commission must be settled at the completion of each shoe unless a player requests an earlier settlement. When a player wishes to cease wagering before the end of a shoe any deferred commission must be settled before the player leaves the game.
 - 11.1.5.2 All outstanding commission shall be collected prior to the commencement of the next shoe and in no event shall the collection of any commission be deferred beyond such point.
 - 11.1.5.3 The amount of commission not collected prior to the time of the winning payout shall be evidenced by placing a marker button indicating the amount of the commission owed in the space provided in front of the dealer on the layout imprinted with the number of the player owing such commission.'.

6. Renumbering of rule 11.3

For rule 11.3, **substitute** —

'11.2 Void wagers

- 11.2.1 A wager on the player's hand shall be void if that hand has an equal point total to that of the banker's hand.
- 11.2.2 A wager on the banker's hand shall be void if that hand has an equal point total to that of the player's hand.'.

7. Revision of irregularities

In rule 12.2, for 'providing that the cutting card has not been exposed in the shoe or drawn from the shoe' **substitute** 'providing that the coup was not the last coup of the shoe'.

Single deck shuffling shoe — minor amendment

For rule 14.14, **substitute** —

'14.14 In the event that a 'single deck shuffling shoe' does not verify that the correct number of cards is available for play, the Dealer shall count all the cards. If the count proves to have too few or too many cards that round of play shall be void.'.

Subordinate Legislation Act 1994

REGULATORY IMPACT STATEMENT

Building (Fees) Regulations 2000

Notice is given in accordance with section 11 of the Subordinate Legislation Act 1994, that a Regulatory Impact Statement (RIS) has been prepared in relation to the Building (Fees) Regulations 2000.

The reason for implementing the proposed statutory rule is to prescribe an appropriate fee to be charged by a reporting authority when carrying out a function required by the Building Act 1993 (as amended).

The Building Act 1993 introduced reforms to the system of building regulation. The Building Regulations 1994, which came into operation on 1 July 1994, supported the implementation of the Act. As a result of the Planning and Environment (Amendment) Act 2000, amendments to the Building Act 1993 were introduced. The amendments to the Building Act 1993 improve the controls regarding demolition of buildings.

The objective of the proposed amendment is to prescribe a fee in relation to a reporting authority preparing reports and consents for an application for a building permit to demolish a building.

The RIS concludes that the introduction of a fee for a report and consent is a modest charge when weighed against the value the community places on its built environment. These costs have been assessed as being of net benefit to the community.

Public comments are invited on the RIS and accompanying Regulations.
