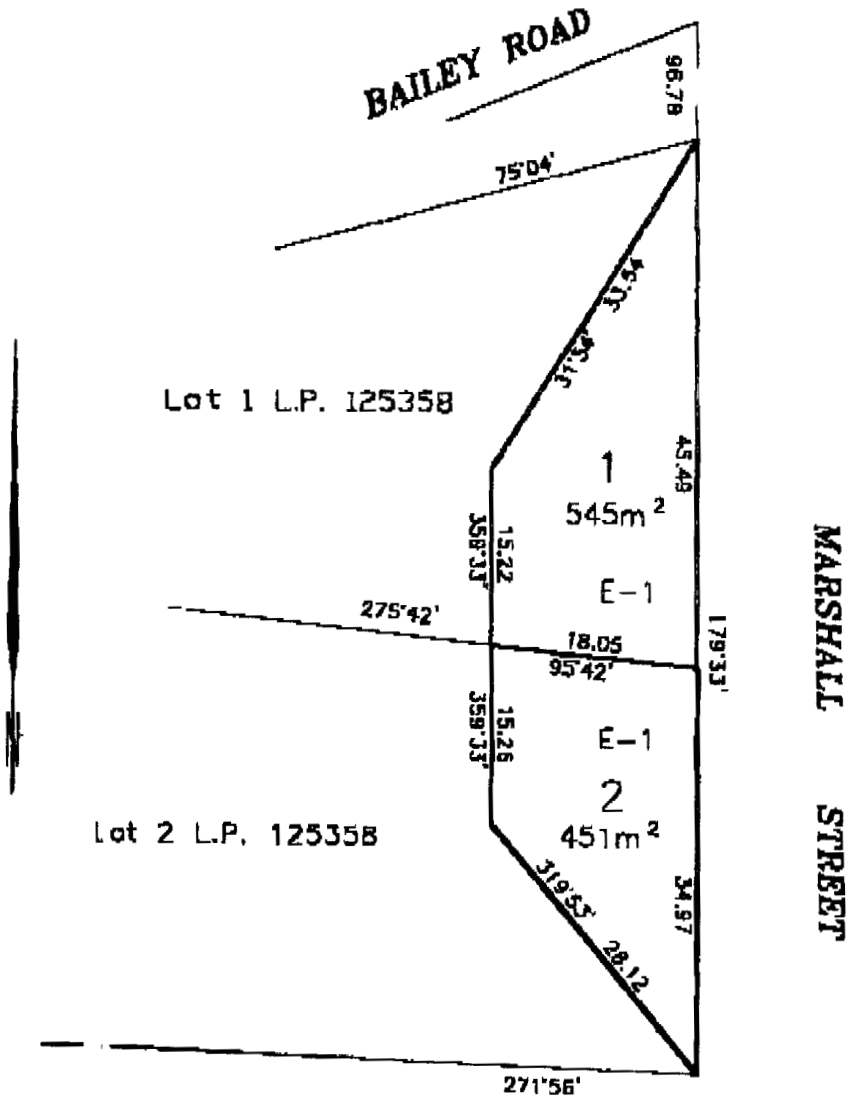

Road Discontinuance

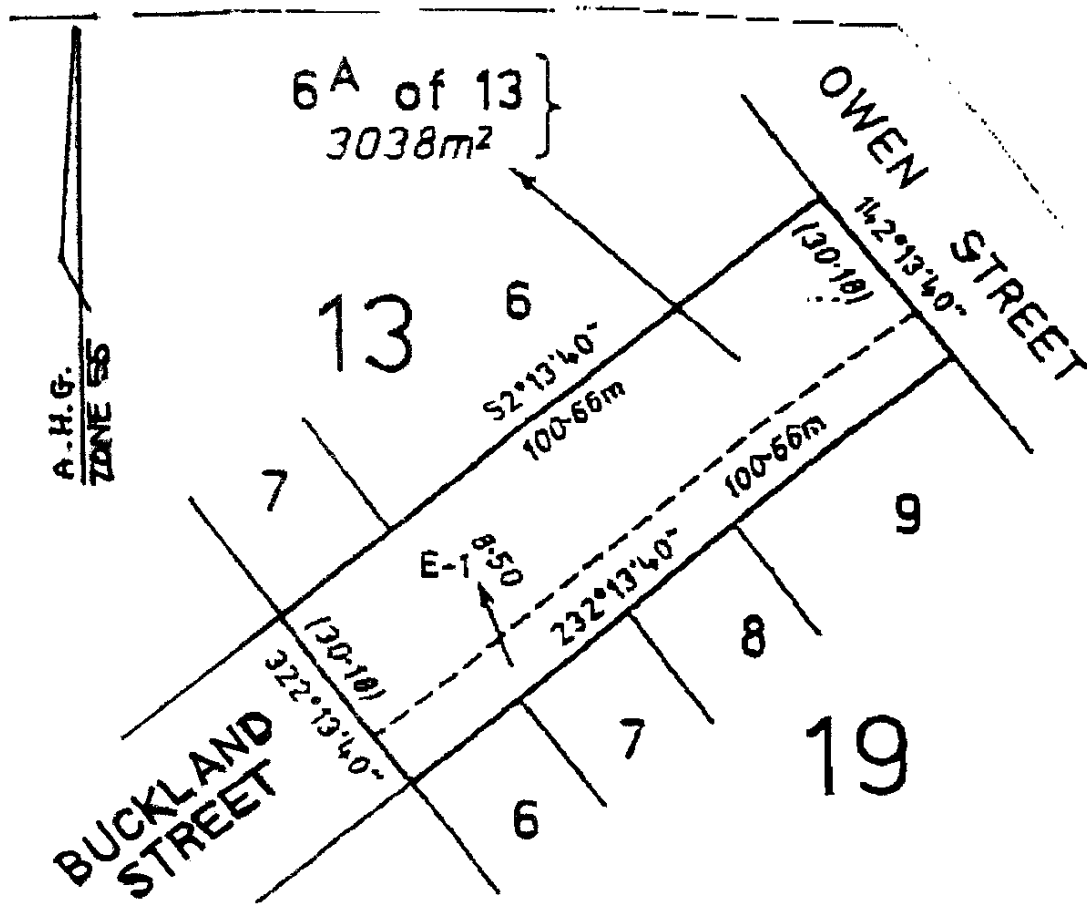

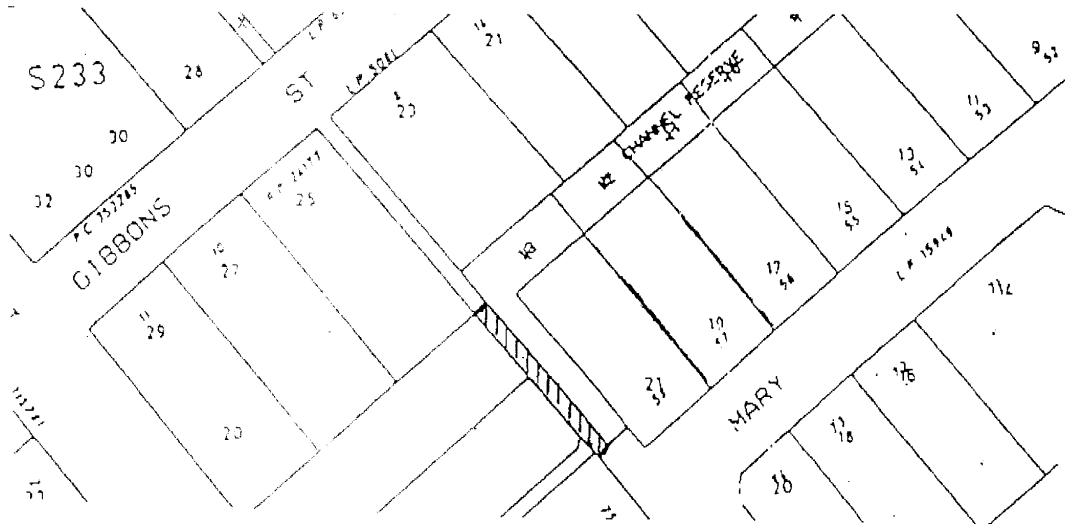
MACEDON RANGES SHIRE COUNCIL

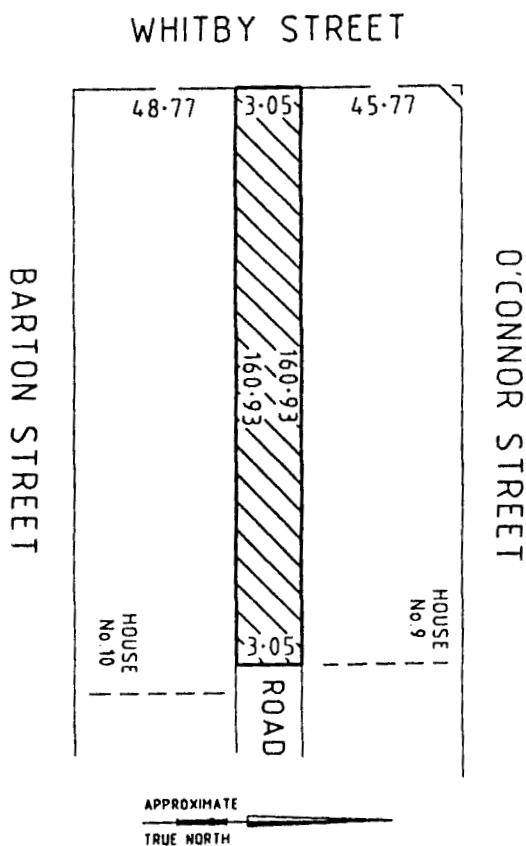

In granting this exemption, the Tribunal noted:

- The position of a CSO is to provide basic legal advice and assistance to ATSI people being detained by police and to assist at court by providing intermediary communication between the solicitor and ATSI client.
- The CSO must have an understanding of and commitment to ATSI culture; have the ability to effectively communicate with ATSI individuals and organisations; have knowledge and experience in working with ATSI individuals and communities; understand the diverse legal and social needs of ATSI people and an ability to identify appropriate strategies to assist VALS clients.
- The CSO has to be acceptable to ATSI individuals and communities. ATSI people who require the assistance of a CSO are in an extremely vulnerable position and distressing circumstances i.e. being held by the police. For this and the foregoing reasons the duties of these positions will be able to be performed most effectively by ATSI people. The reassurance provided by the presence of a supportive Indigenous person can make an enormous difference to the outcome of the ATSI person's arrest and their subsequent wellbeing and access to justice.
- VALS recognise the extreme disadvantage suffered by ATSI people in gaining employment within the sector. It encourages ATSI people to apply for training and staff

development opportunities and to make application for vacant positions. The employment of ATSI people in these CSO positions will help to redress this disadvantage.

- The Applicant was granted a previous exemption which expired on 14 January 2001.

The Tribunal hereby grants an exemption to the applicant from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995** to enable the applicant to advertise for and employ persons of ATSI descent in the position of CSO.
