WILDLIFE (CONTROL OF DEER HUNTING) NOTICE NO. 1/2001

I, Sherryl Garbutt, Minister for Environment and Conservation, make the following Notice:

Wildlife (Control of Deer Hunting) Notice No.1/2001

1. Title

This Notice may be cited as the Wildlife (Control of Deer Hunting) Notice No.1/2001.

2. Objectives

The objectives of this Notice are –

- (a) to prohibit absolutely the taking, destroying and hunting of any taxa of deer in the areas indicated by shading in Schedules 1 and 2 and the area described in Schedule 3; and
- (b) to prohibit absolutely the use of scent-trailing hounds or gun dogs to hunt for Sambar Deer in the areas indicated by shading in Schedules 4 and 5 –

during the period commencing 27 January 2001 and ending 26 January 2002 (both dates inclusive).

3. Authorising provision

This notice is made under section 86 of the **Wildlife Act 1975**.

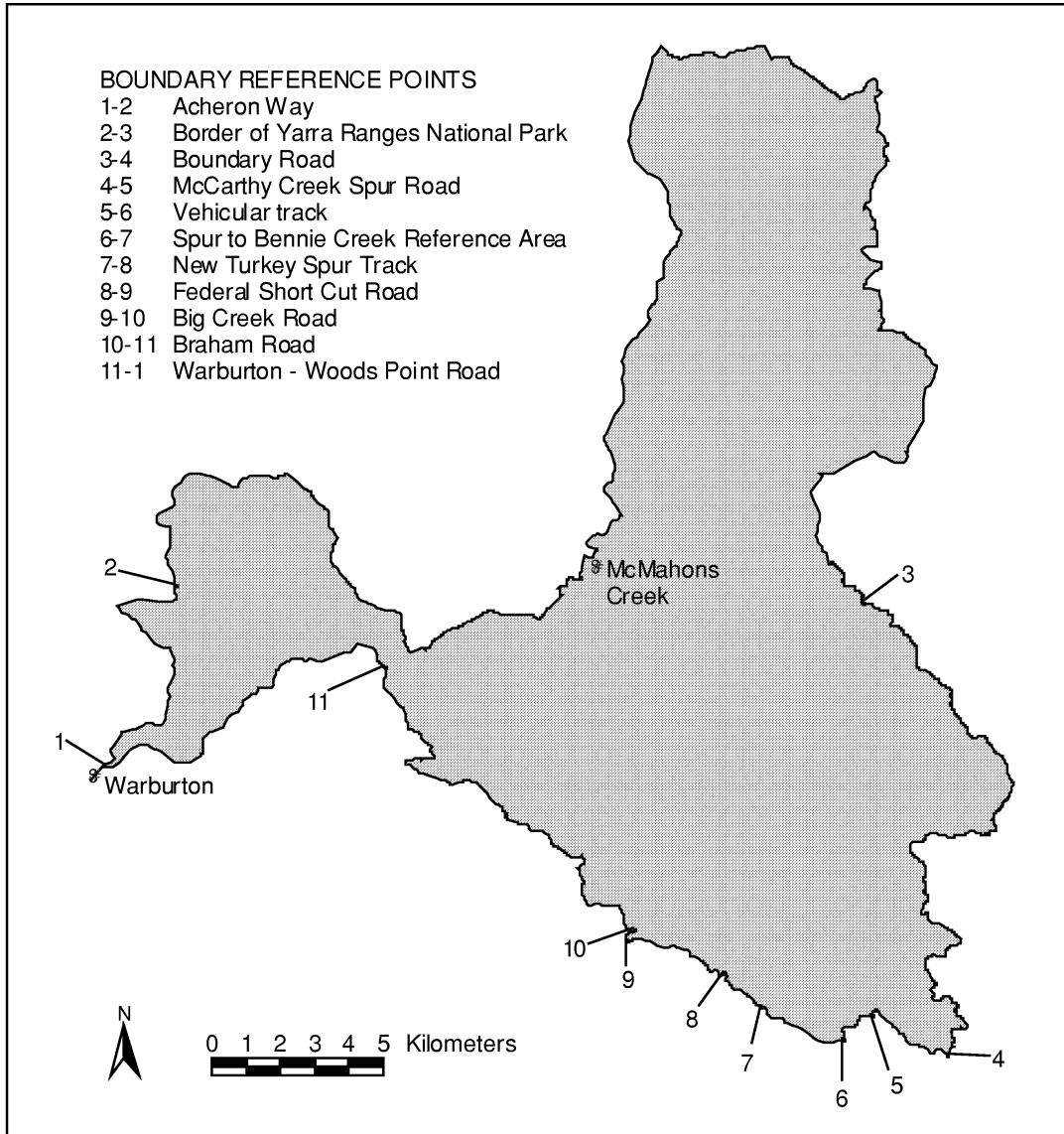
4. Control of hunting of wildlife

- (1) The taking, destroying and hunting of any taxa of deer in the areas indicated by shading in Schedules 1 and 2 and the area described in Schedule 3 is prohibited absolutely during the period commencing 27 January 2001 and ending 26 January 2002 (both dates inclusive).
- (2) The use of scent-trailing hounds or gun dogs to hunt for Sambar Deer in the areas indicated by shading in Schedules 4 and 5 is prohibited absolutely during the period commencing 27 January 2001 and ending 26 January 2002 (both dates inclusive).

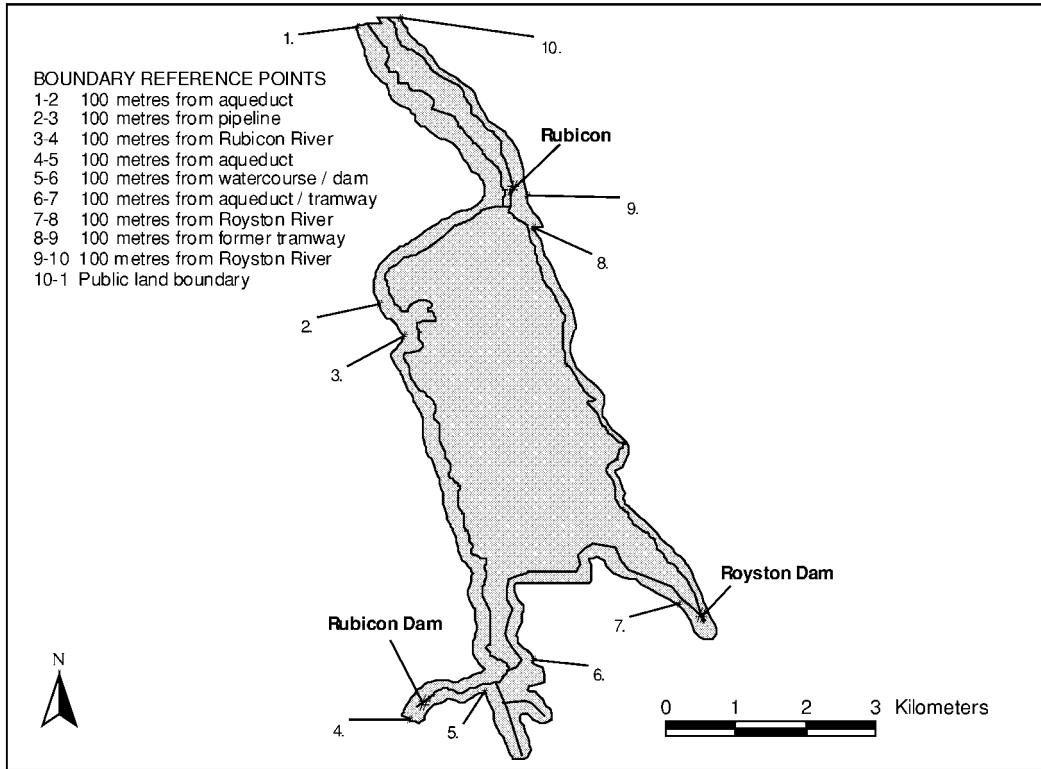
5. Penalty

Any person who contravenes this Notice is guilty of an offence and liable to a penalty of 25 penalty units.

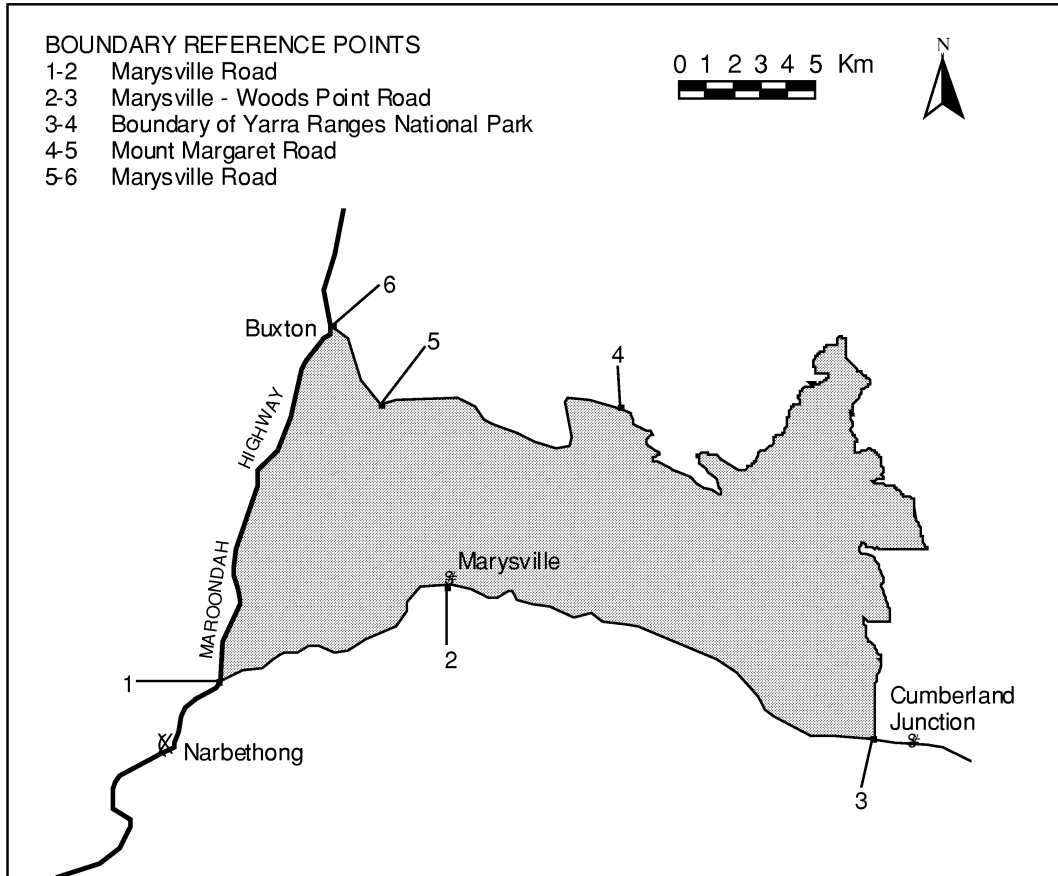

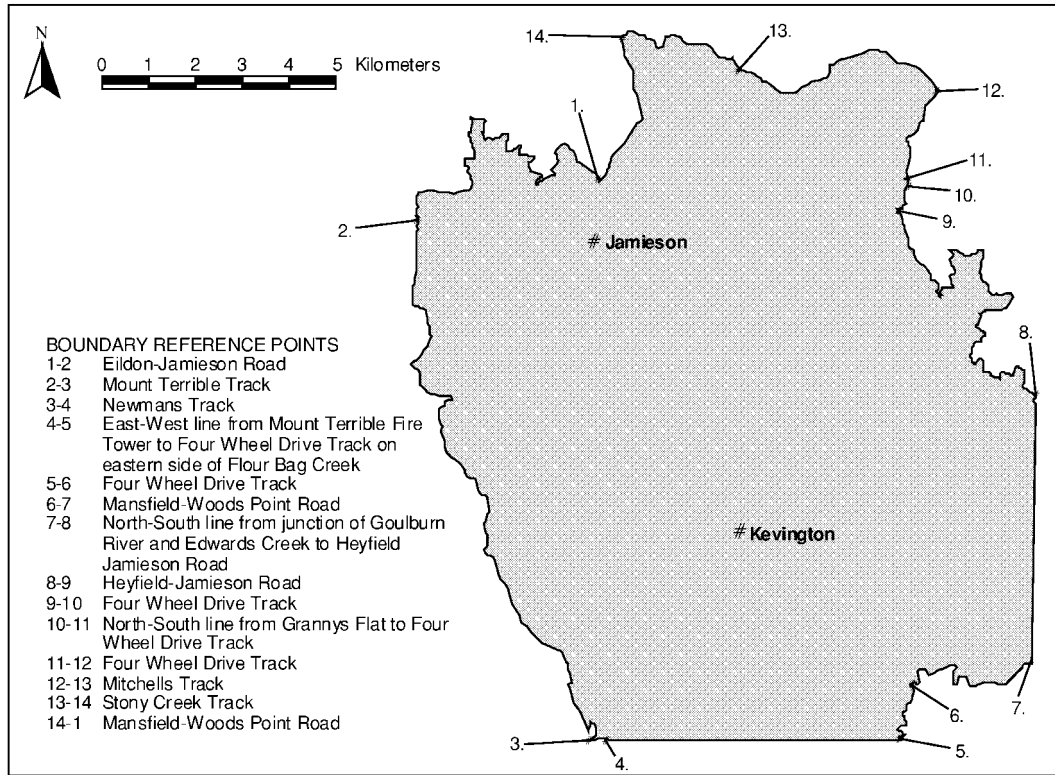
