



Bayside City Council exhibited Amendment C2 – Residential Neighbourhood in May 2000.

Council has considered submissions on this amendment and resolved to adopt the following positions for height control and development density.

Height Control

Council resolved to adopt the Bayside Height Control Study as exhibited but with:

- all HC2 areas (Residential exceptions on the coast) having the same controls as for HC1 areas (Coastal strip) maximum height of two stories or six metres (for a single storey building).
- HC5 (Managed change Northern and Central Bayside) and HC6 (Environmental Enhancement – Eastern Area of Bayside) combined into HC5 (Bayside Residential Density Area) with a two storey maximum height.
- A three storey maximum building height in activity centres (HC7) with a four metre setback for the third storey.

Residential density

The exhibited amendment proposed a range of development densities from 1:200 m^2 to 1:400 m^2 based on the Residential Strategy, street frontage and lot size. Council resolved to adopt the lower density (1:400 m^2) as the maximum for all residential areas of Bayside. In Activity Centres a density of 1:50 m^2 has been adopted.

Council proposes to take this position to the independent Panel Hearing on the amendment that will occur early in 2001.

CONSERVATION, FORESTS AND LANDS (ANGLESEA HEATH) REGULATIONS 2000

I, Sherryl Ann Garbutt, Minister for Environment and Conservation, make the following regulations:

Dated 20 December 2000

SHERRYL GARBUTT Minister for Environment and Conservation

PART 1 - PRELIMINARY

1. Title

These Regulations may be cited as the Conservation, Forests and Lands (Anglesea Heath) Regulations 2000.

2. Objectives

The objective of these Regulations is to provide for the preservation, care and protection of the Anglesea Heath, the preservation of good order in the Anglesea Heath and to regulate the conduct of the public in the Anglesea Heath.

3. Authorising provisions

These Regulations are made under section 82 of the Conservation, Forests and Lands Act 1987.

4. Commencement

These regulations come into operation on the day on which they are published in the Government Gazette.

5. Expiry

These regulations expire on the day that is 10 years after the day on which they come into operation.

6. Definitions

In these Regulations-

"Anglesea Heath" means the land shown by hatching on the plan in the Schedule;

"authorised officer" means an authorised officer appointed under section 83 of the Conservation, Forests and Lands Act 1987 for the purposes of that Act;

"building" includes structure, temporary building and temporary structure;

"contractor" includes any sub-contractor of a contractor;

"fauna" means any animal-life that is indigenous to Victoria whether vertebrate or

invertebrate in any stage of development, but does not include humans or fish;

"flora" means any plant life that is indigenous to Victoria whether vascular or non-vascular and in any stage of development including any other living thing generally classified as flora;

"firearm" has the same meaning as in the Firearms Act 1996;

"indigenous fish" includes any kind or species of fish including crayfish and any other crustacea or mollusc indigenous to Victoria or Victorian waters;

"parking area" means any area set aside under regulation 8 for the parking of vehicles;

"Parks Victoria" means the body corporate established by Part 2 of the Parks Victoria Act 1998;

"Secretary" means the body corporate established by Part 2 of the Conservation, Forests and Lands Act 1987;

"vehicle" has the same meaning as in the Road Safety Act 1986.

7. Exemptions from the operation of the regulations

(1) These Regulations do not apply to any of the following persons when acting in the course of that person's duties-

- (a) a member of the police force;
- (b) an authorised officer;
- (c) a person employed by the Secretary under Part 3 of the Public Sector Management and Employment Act 1998 or an employee of Parks Victoria or Alcoa of Australia Limited;
- (d) a contractor, volunteer or other person carrying out any work for or acting on the instructions of the Secretary or Parks Victoria or Alcoa of Australia Limited;
- (e) a person dealing with a fire, flood or other public emergency.

(2) A person, acting in accordance with a lease, licence, permit or right granted or issued under the Land Act 1958 or an Act relating to Crown land over the Anglesea Heath is not subject to these Regulations, to the extent that the activities authorised by that lease, licence, permit or right are inconsistent with these Regulations.

PART 2 - GENERAL CONTROL OF THE ANGLESEA HEATH

8. Setting aside areas for particular purposes

(1) The Minister may set aside areas in the Anglesea Heath for one or more of the following purposes-

- (a) the parking of vehicles;
- (b) walking tracks;
- (c) walking, riding, driving or leading horses;
- (d) public amenities or facilities.

(2) The Minister may set aside areas in the Anglesea Heath to which access is prohibited -

- (a) because of the known or suspected presence of dangerous substances or unexploded ordnance;
- (b) for the possession or carriage of glass bottles, glass containers or glass utensils;
- (c) for other reasons of public safety;
- (d) for the purpose of preservation of flora, fauna and indigenous fish;
- (e) for the purpose of planting of trees, shrubs, grass or other vegetation;
- (f) for the purpose of re-establishment of vegetation;
- (g) for the purpose of reclamation of land.
- (3) The Minister may-
- (a) determine the times or periods at which areas set aside under sub-regulation (1) may be used for the purpose for which they are set aside; and
- (b) cause signs or notices to be erected or displayed indicating the areas set aside under sub-regulation (1) and the purposes for which they are set aside; and
- (c) determine the times or periods at which areas set aside under sub-regulation (2) must not be used for the purpose for which access to the area has been prohibited; and
- (d) cause signs or notices to be erected or displayed indicating the areas set aside under sub-regulation (2) and the purposes for which access is prohibited.

9. Prohibited activities

(1) A person must not in the Anglesea Heath use, carry or be in possession of any hunting knife, bow, arrow, firearm, poison, trap, snare, net, spear gun, spear or similar implement.

(2) A person must not in the Anglesea Heath cut, fell, pick, remove or destroy any wildflower, plant, shrub, tree or other vegetation whether alive or dead.

(3) A person must not in the Anglesea Heath wilfully plant or introduce any seed, tree, shrub, fern or other vegetation, or any part of any tree, shrub, fern or other vegetation.

(4) A person must not in the Anglesea Heath -

- (a) wilfully excavate, remove, deface, damage, or otherwise interfere with any rock, natural feature, historical, cultural, landscape, geomorphological or geological features or archaeological remains or relics; or
- (b) dig or remove from, or wilfully take into the Anglesea Heath any gravel, stone, shell, grit, sand, loam or other like material.

(5) A person must not in the Anglesea Heath wilfully remove, cut, damage, displace, deface or interfere with a memorial, sign, notice board, seat, table, gate, post, fence, bridge or building constructed or erected in the Anglesea Heath.

(6) A person must not in the Anglesea Heath cross an area where there is an identified track for walking except by way of the identified track.

(7) A person must not in the Anglesea Heath take into or possess any glass bottle, glass container or glass utensil in an area set aside under regulation 8 to which access is prohibited for the possession or carriage of such containers.

(8) A person must not enter an area in the Anglesea Heath set aside under regulation 8 to which access is prohibited -

- (a) for the purpose of preservation of flora, fauna and indigenous fish; or
- (b) for the purpose of planting of trees, shrubs, grass or other vegetation; or
- (c) for the purpose of re-establishment of vegetation; or
- (d) for the purpose of reclamation of land; or

(e) for reasons of public safety.

10. Lighting or maintaining fires

(1) A person must not light or maintain in the Anglesea Heath-

- (a) a fire; or
- (b) a barbecue.

(2) Sub-regulation (1) does not apply to a person who lights or maintains a fire or barbecue using liquid or gaseous fuel in the open air provided -

- (a) the fire is contained in a fireplace provided by the Committee; or
- (b) the fire is contained in an appliance designed and commercially manufactured to use that fuel; and
- (c) the appliance when alight is placed in a stable position; and
- (d) the ground and airspace within a distance of 3 metres of the appliance are clear of flammable material.

(3) A person who has lit or maintained a fire or barbecue in the manner referred to in sub-regulation (2) must completely extinguish that fire or barbecue before leaving the place of the fire or barbecue.

11. Behaviour

A person must not in the Anglesea Heath -

- (a) use any profane, indecent or obscene language; or
- (b) use any threatening or abusive words; or
- (c) behave in a riotous, indecent, offensive or threatening manner.

12. Games and activities

A person must not in the Anglesea Heath throw a stone or missile, play a game or take part in any activity which is likely to cause danger or unreasonable disturbance to other persons.

13. Advertising, public address

- (1) A person must not in the Anglesea Heath -
- (a) distribute, erect, affix or display handbills, placards, notices, pamphlets, books, papers or other advertising material; or
- (b) solicit or collect money or orders for goods or services; or
- (c) take part in any public entertainment for gain or reward; or
- (d) preach, declaim or deliver any public address.

(2) Sub-regulation (1) does not apply to a person acting in accordance with a current written authority under regulation 22 which allows the person to engage in the particular activity.

14. Use of amenities

(1) A person must not enter or use a facility in the Anglesea Heath set aside as a public amenity for the use of persons of the opposite sex.

(2) Sub-regulation (1) does not apply to the entering or use of a facility by a child under the age of 6 years when accompanied by an adult.

15. Camping

A person must not camp in the Anglesea Heath or use a tent, caravan or other mobile structure for camping in the Anglesea Heath.

16. Hygiene

A person in an area of the Anglesea Heath in which toilet facilities are not readily accessible, must bury all his or her faeces not less than 100 metres from any river, stream, creek, well, spring, dam, bore or watercourse.

17. Dogs

(1) A person must not -

- (a) bring a dog into the Anglesea Heath; or
- (b) allow a dog under that person's control to enter the Anglesea Heath; or
- (c) allow a dog to remain in the Anglesea Heath.

(2) Sub-regulation does not apply to a person who brings a dog into Anglesea Heath or allows a dog to enter or remain in the Anglesea Heath if the dog is used by a disabled person to assist that person with respect to the person's disability.

18. Other animals

(1) A person must not -

- (a) bring an animal, other than a dog in accordance with regulation 17(2), into the Anglesea Heath; or
- (b) allow any such animal to enter or remain in the Anglesea Heath.

(2) Sub-regulation (1) does not apply to any person who walks, rides, drives or leads a horse, in an area in the Anglesea Heath which is set aside under regulation 8 for walking, driving, riding or leading horses.

(3) A person must not-

- (a) ride or drive a horse in the Anglesea Heath in a manner that may endanger a person or animal; or
- (b) leave a horse unattended in the Anglesea Heath.

19. Vehicles

A person must not bring a vehicle into or leave a vehicle standing in the Anglesea Heath in an area set aside under regulation 8-

- (a) for the purpose of the preservation of flora, fauna and indigenous fish; or
- (b) for the purpose of the planting of trees, shrubs, grass or other vegetation; or
- (c) for the purpose of the re-establishment of vegetation; or
- (d) for the purpose of the reclamation of land; or
- (e) to which access is prohibited for reasons of public safety.

20. Fishing

A person must not fish or attempt to take fish in waters in the Anglesea Heath.

21. Events and activities

(1) A person must not organise or conduct in the Anglesea Heath any sporting contest, research, demonstration, training or training class.

(2) Sub-regulation (1) does not apply to a person who organises or conducts the particular activity referred to in that sub-regulation in accordance with a current written authority under regulation 22 which allows the person to organise or conduct the particular activity.

(3) A person must not organise or conduct in the Anglesea Heath -

- (a) any fete, carnival, concert or other public event; or
- (b) any social event for 100 or more persons; or
- (c) any commercial event or activity.


(4) Sub-regulation (3) does not apply to a person who is acting in accordance with a current written authority under regulation 22 which allows the person to engage in the particular activity referred to in sub-regulation (3).

22. Written authorities

(1) The Minister may issue a written authority for any of the activities referred to in regulations 13(1), 21(1) and 21(3).

(2) An authority given in writing by the Minister under sub-regulation (1)-

- (a) is subject to such conditions as the Minister determines; and
- (b) may be cancelled at any time by the Minister by notice given in writing to the holder of the authority.
