Accident Compensation (WorkCover Insurance) Act 1993

WORKCOVER INSURANCE PREMIUMS ORDER (NO. 8) 2000/2001

Under and for the purposes of Item 1 of Schedule 3 to the WorkCover Insurance Premiums Order (No. 8) 2000/2001, the Victorian WorkCover Authority has determined that the values of F_0^c , F_1^c and F_2^c , for the purposes of calculating the Experience Factor E, for a period of coverage of a workplace, are respectively the relevant numbers specified in the following Table, opposite the authorised agent which calculated the costs of claims of the workplace:
