Electricity Industry Act 2000

PUBLICATION OF TARIFFS PURSUANT TO SECTIONS 35 AND 37

CitiPower Pty (ACN 064 651 056) has determined the following tariffs:

- for domestic and small business customers pursuant to section 35(1)(a) of the **Electricity Industry Act 2000** (as amended or replaced) to take effect from 1 January 2002 until such time as other tariffs are determined and gazetted in accordance with the **Electricity Industry Act 2000**; and
- for deemed contracts with former franchise customers of CitiPower pursuant to section 37(1) of the **Electricity Industry Act 2000** (as amended or replaced) to take effect from 1 January 2002 until such time that the contract is terminated, the customer enters into a new contract with CitiPower, or other tariffs are determined and gazetted in accordance with the **Electricity Industry Act 2000**.
