



STATE HIGHWAY


79/01 Strzelecki Highway in the Latrobe City shown cross-hatched on plan numbered GP 19542.

NOTIFICATION OF WITHDRAWAL OF AUTHORISED ACCESS TO A FREEWAY


Whereas pursuant to section 105(1) of the Country Roads Act 1958 the Country Roads Board in 1970 authorised access to a by-pass road now known as the Western Freeway, being points of access identified in the Schedule to this instrument.

And whereas the authorisation was subject to a condition that the Country Roads Board may withdraw the authorisation at any time it so desires.

The Roads Corporation as successor in law to the Country Roads Board, pursuant to sections 232 and 233 of the **Transport Act 1983** and pursuant to section 41A of the **Interpretation of Legislation Act 1984** and all other enabling powers, hereby withdraws and revokes that authorisation.


