REGULATORY IMPACT STATEMENT

Proposed Building (Swimming Pool Fences)

Regulations 2001

Notice is given as required by Section 11 of the **Subordinate Legislation Act 1994** of the proposed making of the Building (Swimming Pool Fences) Regulations 2001.

The objectives of the proposed regulations to be made under the **Building Act 1993**, as amended by the **Building (Amendment) Act 2001**, are to–

- (a) to prescribe matters relating to the construction, installation, maintenance, operation and use of swimming pool barriers and spa barriers;
- (b) to prescribe a penalty not exceeding 50 penalty units for a contravention of those regulations; and
- (c) to generally improve the operation of those regulations.

A Regulatory Impact Statement has been prepared in accordance with the **Subordinate** Legislation Act 1994. The statement examines the costs and benefits of the proposed regulations and possible alternatives. The statement concludes that the proposed regulations are the most efficient method of achieving the objectives. The reason for the proposed regulations is to reduce the risk of children drowning in backyard swimming pools and spas and to introduce maintenance and operational controls for safety equipment associated with swimming pools and spas.
