PROPOSED BUILDING (SINGLE DWELLINGS) REGULATIONS 2001

Notice of Decision

I, John Thwaites, Minister for Planning and Minister responsible for the administration of the **Building Act 1993**, give notice under section 12 of the **Subordinate Legislation Act 1994** as follows—

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Building (Single Dwellings) Regulations 2001 and advertised inviting public comment. Thirty one submissions were received and considered.

I have decided that the proposed Building (Single Dwellings) Regulations 2001 should be made with minor amendments, to improve the operation and consistency of the Regulations, as well as a number of more substantive amendments which are outlined below—

Private Open Space: Amendments to the definition of "private open space", and the overlooking, overshadowing, private open space and fence overshadowing provisions as they relate to private and secluded private open space.

- Maximum Street Setback: Clarification that
 this provision only applies to new Class 1
 buildings (class 1), rather than alterations
 and outbuildings. Application of a maximum
 lot size (1 acre) to which this provision
 relates to remove negative implications for
 development in rural areas.
- Minimum Street Setback: Clarification that this provision does not relate to a footway, alley, lane or right-of way.
- Building Height: Clarification of restrictions on building height for that part of a building between a wall on a boundary and the standard 1m setback.
- Solar access to north-facing windows:
 Restriction of application of provision to protect only that part of a window within 3 metres of the boundary. Inclusion of a restricted range of allowable encroachments with restrictions on the extent of encroachment so as not to create additional shading.
- Overlooking: Clarification that line of sight to be measured at and below a horizontal line (i.e. not overlooking upwards). Inclusion of raised open spaces below 800mm in height in concession where 1.8m visual barriers provided.
- Minor amendments to the range and restrictions on allowable encroachments within setbacks for clarification, consistency and improved outcomes.
