WHITEHORSE PLANNING SCHEME
Notice of Approval of Amendment
Amendment C39

The Minister for Planning has approved Amendment C39 to the Whitehorse Planning Scheme. The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- Rezones various portions of land fronting the northern and southern sides of Whitehorse Road/Maroondah Highway, generally between Kingsley Crescent, Mont Albert and Shipley Street, Box Hill (currently affected by a Public Acquisition Overlay) to a Road Zone.
- Deletes the Public Acquisition Overlay applying to various portions of land fronting the northern and southern sides of Whitehorse Road/Maroondah Highway, generally between Kingsley Crescent, Mont Albert and Shipley Street, Box Hill.
- Changes the Schedule to Clause 45.01 by deleting the Director of Public Transport as the acquisition authority for the widening of Whitehorse Road/Maroondah Highway associated with the Box Hill tram line extension.
- Changes the Schedules to Clauses 52.03 and 81 by inserting the incorporated document 'Whitehorse Road/Maroondah Highway Tram Line Extension to Station Street, Box Hill, December 2001' into the Whitehorse Planning Scheme to facilitate the construction of the tram line extension.
