



82/01 Princes Freeway in the City of Latrobe shown hatched and cross-hatched on plan numbered GP 20037.




# STATE HIGHWAY

# DISCONTINUANCE OF ROADS OR PARTS OF ROADS




13/01 The land in the City of Latrobe described as formerly Princes Freeway, Parish of Maryvale, shown cross-hatched on plan numbered RD 20037.




