Subordinate Legislation Act 1994 NOTICE OF DECISION

Proposed Building (Swimming Pool Fences) Regulations 2001

I, John Thwaites, Minister for Planning, give notice under section 12 of the **Subordinate Legislation Act 1994**, that I have decided that the proposed Building (Swimming Pool Fences) Regulations 2001 be made.

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Building (Swimming Pool Fences) Regulations 2001 and advertised inviting public comment. A total of five submissions were received and considered.

I have decided that the proposed Building (Swimming Pool Fences) Regulations 2001 should be made with minor amendments. The minor amendments are to introduce a six month transitional provision to allow owners of swimming pools constructed before 8 April 1991 a reasonable time to install a closing device to gates or doors forming part of a safety barrier or fence.
