SPECIAL

Film Act 2001 TRANSFER ORDER

- I, Mary Elizabeth Delahunty, Minister for Arts, allocate under section 45(a) of the Act to Film Victoria, or under section 45(b) of the Act to the Australian Centre for the Moving Image (ACMI), such of the property, rights, and liabilities of the Cinemedia Corporation as are specified in the sub-clauses below:
- 1. All property, rights, liabilities in respect of agreements, consents and permits and interests in land:
 - 1.1 Described and identified in Schedule 1 to ACMI; and
 - 1.2 All other Cinemedia Corporation agreements, leases, consents and permits to Film Victoria
- 2. All property, rights, liabilities in respect of the bank accounts and investments accounts:
 - 2.1 Described and identified in Schedule 2 to Film Victoria; and
 - 2.2 All other Cinemedia Corporation bank accounts and investment accounts to ACMI
 - (Note: In Schedule 2, 'Old Name' refers to the Cinemedia account name, and 'New Name' refers to the Film Victoria account name in relation to the same account)
- 3. All property, rights, liabilities in and in relation to any business name registered under the **Business Names Act 1962** and to any trademark registered under the **Trademark Act 1995** (Cwth) in relation to Cinemedia Corporation
 - 3.1 Described and identified in Schedule 3 to Film Victoria; and
 - 3.2 All other Cinemedia Corporation registered business names to ACMI
- 4. All property, rights and liabilities in respect of documents, records and files in whatever
 - 4.1 Held, stored or used solely by the following Cinemedia Corporation work areas:
 - Melbourne Film Office
 - Film Victoria
 - Digital Media Fund
 - Screen Culture
 - Legal and Business Affairs (except those documents, records and files relating to ACMI Agreements)
 - Corporate Operations, Film Victoria; or

Relating to the personnel records of employees listed under section 54 of the Film Act 2001 for transfer to Film Victoria

to Film Victoria; and

- 4.2 All other Cinemedia Corporation documents, records and files in whatever format to ACMI
- 5. All personal property that is, immediately before the date of this Order, ordinarily used in connection with the operation of Cinemedia Corporation, and other than personal property allocated under other sub-clauses in this Order:
 - 5.1 The personal property that is described and identified in Schedule 4 to Film Victoria; and
 - 5.2 All other Cinemedia Corporation personal property to ACMI
 - (Note: Schedule 4 lists personal property above the Department of Treasury and Finance Asset Register level of \$1,000. It is intended that Cinemedia personal property not listed on the Cinemedia Asset Register (valued at below \$1,000) will be divided by agreement between Film Victoria and ACMI)

- 6. All property, rights, liabilities in respect of software licences:
 - 6.1 Installed on IT equipment transferred to Film Victoria as described in Schedule 4 to Film Victoria; and
 - 6.2 All other Cinemedia Corporation software licences to ACMI
- 7. All property, rights, liabilities in respect of IT leases:
 - 7.1 Described and identified in Schedule 5 to Film Victoria; and
 - 7.2 All other Cinemedia Corporation IT leases to ACMI
- 8. All other assets and liabilities of Cinemedia Corporation not allocated under other sub-clauses in this Order, to ACMI
