WILDLIFE (CONTROL OF HUNTING) NOTICE NO. 3/2001

I, Sherryl Garbutt, Minister for Environment and Conservation, make the following Notice: Dated 13 March 2001

Wildlife (Control of Hunting) Notice No. 3/2001

1. Title

This Notice may be cited as the Wildlife (Control of Hunting) Notice No. 3/2001.

2. Objective

The objective of this Notice is to prohibit absolutely the taking, destroying and hunting of the taxa of duck specified in Schedule 1 below in the areas of Victoria specified in Schedules 2 and 3 below during the period commencing on Saturday 17 March 2001 and ending on Monday 11 June 2001 (both dates inclusive).

3. Authorising provision

This notice is made under section 86 of the Wildlife Act 1975.

4. Hunting of duck prohibited

The taking, destroying and hunting of the taxa of duck specified in Schedule 1 is prohibited -

- (a) in the area described in Schedule 2; and
- (b) in the area described in Schedule 3 –

during the period commencing on Saturday 17 March 2001 and ending on Monday 11 June 2001 (both dates inclusive).

5. *Contravention of notice*

A person must not contravene any part of this Notice. Penalty: 25 penalty units.

2. Objective

The objective of this Notice is to prohibit absolutely the taking, destroying and hunting of the taxa of duck specified in Schedule 1 below in the area of Victoria specified in Schedule 2 below during the period commencing on Saturday 17 March 2001 and ending on Friday 23 March 2001 (both dates inclusive).

3. Authorising provision

This notice is made under section 86A of the Wildlife Act 1975.

4. Hunting of duck prohibited

The taking, destroying and hunting of the taxa of duck specified in Schedule 1 is prohibited in the area described in Schedule 2 during the period commencing on Saturday 17 March 2001 and ending on Friday 23 March 2001 (both dates inclusive).

5. Contravention of notice

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
