Islander people only can enrol in the Certificate IV in Indigenous Women's and Babies Health course, except under special circumstances where it has been noted that non-indigenous people may be considered subject to the approval of the course co-ordinator.

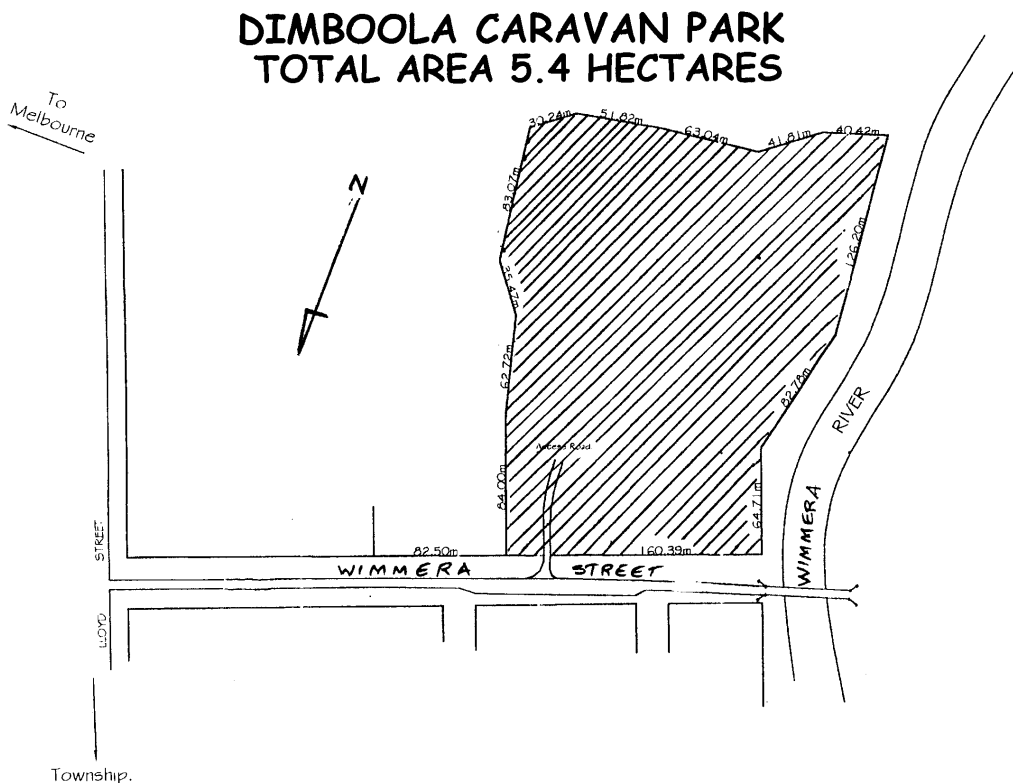

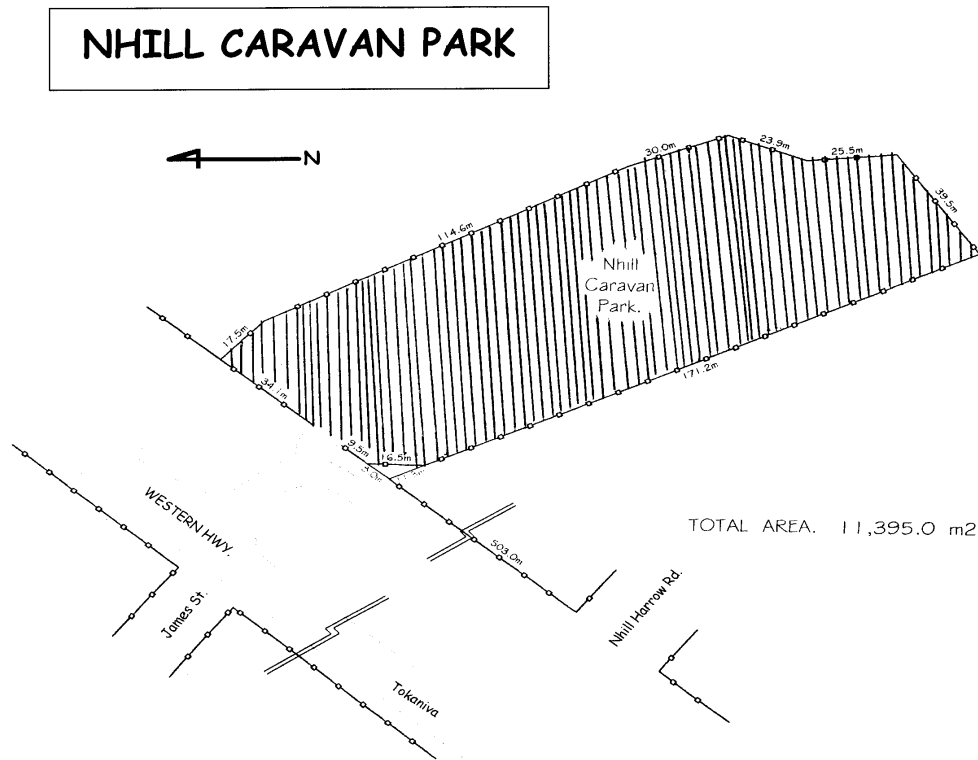
