PROCLAMATION OF REVOCATION OF THE PROCLAMATION OF "ST GEORGE'S HOSPITAL AND INNER EASTERN GERIATRIC SERVICE GERIATRIC PSYCHIATRY SERVICE"

I, John Landy, Governor of Victoria, acting with the advice of the Executive Council and under section 94 of the **Mental Health Act 1986** (the Act), proclaim that the following proclamations are revoked:

- (a) the proclamation made by the Governor in Council on 3 December 1996 under section 94(1)(b) of the Act of the St George's Hospital and Inner Eastern Geriatric Service situated at 283 Cotham Road, Kew to be an approved mental health service known as the "St George's Hospital and Inner Eastern Geriatric Service Geriatric Psychiatry Service", as amended by the proclamation described in paragraph (b); and
- (b) the proclamation made by the Governor in Council on 29 September 1998 under section 94 of the Act in order to change the name of the approved mental health service known as the "St George's Hospital and Inner Eastern Geriatric Service Geriatric Psychiatry Service" to the "St George's Health Service Geriatric Psychiatry Service".
