CASINO RULES NOTICE NO. 8 OF 2001

Rules of the Game—Crown Com-Bo

By this notice, the Victorian Casino and Gaming Authority **amends** the Rules in respect of the game “Crown Com-Bo”¹ as set out in the Schedule.

This notice operates with effect from 4.00am on 18 April 2001.

New definition

After the definition of “Void”, insert—

“**WND**” (Winning Number Display) means a device designed to display on a screen visible to all players at the gaming table the outcome of at least the last round of play.”.

New Rule 2.5

After rule 2.4, insert—

“2.5 A WND may be used.”.

New Rule 4.4

After rule 4.3, insert—

“4.4 The first card from the shoe will be “burned” face down by placing it into the discard holder and shall not be shown unless a player requests to see it.”.

New Rule 9.10

After rule 9.9, insert—

“9.10 The WND must be disregarded if the WND displays a result other than a result drawn in accordance with rule 7.3.”.
