SPECIAL

ROAD SAFETY (VEHICLES) REGULATIONS 1999

Class 1 Notice as to Material for Warning Signs on Class 1 Vehicles

Regulation 502 of the Road Safety (Vehicles) Regulations 1999 provides that the Roads Corporation may by a notice published in the Government Gazette exempt a category of class 1 vehicles from -

- (a) a mass or dimension limit, other than a limit that relates to a GVM, a GCM or a manufacturer's limit; or
 - (b) any other requirement -
- set out in Schedule 1 to the Regulations.

Clause 15 of Schedule 1 to the Regulations provides that:

1. A warning sign on a class 1 vehicle must be made of stiff, flat, weatherproof material.
2. Despite sub-clause (1), the rear sign on a class 1 vehicle may be made of a flexible material if the load is unsuitable for a stiff sign.

In accordance with these provisions, I, Geoff Kloot, delegate of the Corporation, exempt all categories of class 1 vehicles from the requirement in Clause 15(1) of Schedule 1 to the Regulations, subject to the following conditions:

- (a) The warning sign is made of a flexible material; and
- (b) The warning sign is held taut and is clearly visible and is unlikely to become dislocated, furl or otherwise become difficult for other highway users to read; and
- (c) The warning sign is maintained and displayed in such a way that its message can be easily read by other highway users.

The expressions used in this Notice have the same meaning as in the Regulations.

This Notice comes into operation on 9 April 2001 and expires on 5 April 2006.
