





Notice is given that, having carried out a review of dog controls, the Council of the City of

Kingston has resolved to:

- 1. Revoke the Order made by Council pursuant to Section 26 of the **Domestic (Feral and Nuisance)** Animals Act 1994 made on 24 August 1998.
- Amend Local Law 4 (Foreshore Reserves) by revoking the following clauses:- 13 (1), (2), (3), (4), (5), (6), (8), (9), (10), (11).

The purpose and general purport of Local Law 4 is to allow for and protect the quiet enjoyment by people of the Foreshore Reserve, control and prohibit nuisances on the Foreshore Reserve, and provide for equitable access to and enjoyable use of the Foreshore Reserve. The clauses revoked regulated dogs on the Foreshore Reserve, which will now be regulated by way of an Order pursuant to the **Domestic (Feral and Nuisance)** Animals Act 1994. A copy of Local Law 4 as amended may be inspected or purchased for the sum of \$2 at the Mentone Office, Brindisi Street, during office hours.

3. Make the following order pursuant to Section 26 of the Domestic (Feral and Nuisance) Animals Act 1994.

- a) No dog access will be allowed in or onto the Foreshore Reserve sand areas from 1 November - 31 March between 10.00 a.m. - 7.30 p.m.
- b) The 'No dog Zone' boundaries in the northern district be amended to include the entire foreshore bounded by the Mordialloc Creek, Nepean Highway, Beach Road and the north western boundary of the Bay Street car park.
- c) The south-eastern boundary of the designated Mentone foreshore off leash area be extended to the Plummer Road entry point during the designated access times.
- d) The sand areas of the foreshore reserve be off leash between sunrise and 10.00 a.m. between 1 November 31 March with the exception of the Mordialloc No Dog Zone.
- e) Outside the Mordialloc No Dog Zone the sand areas of the foreshore reserve be off leash before 10.00 a.m. and after 3.00 p.m. between 1 April and 31 October.
- f) Outside of the Mordialloc No Dog Zone dogs must remain on leash in or on the foreshore reserve between 10.00 a.m. - 3.00 p.m. between 1 April and 31 October unless in a designated off leash area.
- g) Not withstanding clause b) of this order, dogs be permitted on leash only at anytime on the concrete pathway which passes along the edge of the Mordialloc No Dog Zone as signed;
- h) Outside of the Mordialloc No Dog Zone dogs must remain on leash in or on the foreshore reserve between 7.30 p.m. and sunrise between 1 November – 31 March unless in a designated off leash area.

Note that for the purposes of this order "sand area" means:

- a) north of the Mordialloc No Dog Zone all areas of the foreshore which are exclusively sand underfoot (i.e. excludes concrete pathways, maintained grass areas, vegetated areas and cliff tops);
- b) south of Mordialloc No Dog Zone the entire foreshore reserve including vegetated areas.

- (i) promote a physical and social environment free from hazards to health in which the residents of and visitors to the municipal district can enjoy a quality of life that meets the general expectations of the community;
- (ii) protect and promote access, safety and amenity within the municipal district;
- (iii) regulate and control activities within the municipal district that may be dangerous, unsafe or detrimental to the environment or to the quality of life of persons residing in or visiting the municipal district; and
- (iv) provide for the peace, order and good government of the municipal district.

The general purport of the proposed Local Law is as follows:

- Part 2 of the Local Law contains provisions relating to activities on private land, specifically in relation to unsightly land and land kept in a dangerous manner, caravans and scareguns;
- (ii) Part 3 of the Local Law contains provisions relating to activities on other land, specifically in relation to motorised recreational vehicles, and the leaving or allowing the leaving of any bulk rubbish container, storage container or used clothing bin on, or other thing that obstructs the full use of any road, Council land or public place;
- (iii) Part 4 of the Local Law contains provisions relating to the applying for, issuing, cancellation and the keeping of a register of permits, the issuing of Notices to Comply and action that may be taken in urgent circumstances, infringement notices and payment of penalties, and exemptions and dispensation.

A copy of the proposed Local Law may be obtained from the Council Office at Anderson Street, Lilydale or from the Yarra Ranges Service Centres at Healesville, Monbulk, Upwey and Yarra Junction. A copy may also be viewed on the Shire web site (www.yarraranges.vic.gov.au). Any person affected by the proposed Local Law may make a submission in writing in accordance with section 223 of the Local Government Act 1989 within 14 days of the date of publication of this notice.

Following consideration of submissions Council may resolve either to make the Local Law with or without amendment, to not make the Local Law, or to give notice of its intention to make a different Local Law.

Policy Guidelines

Council also intends to adopt Policy Guidelines to assist Council staff in administration of the proposed Local Law. The Policy Guidelines do not form part of the Local Law. Copy of the proposed Policy Guidelines may be obtained and submissions may be made and will be considered in the same manner as detailed above in respect of the proposed Local Law.







Plant Health and Plant Products Act 1995

DECLARATION OF A CONTROL AREA AT BENDIGO FOR THE PURPOSE OF PREVENTING THE SPREAD OF QUEENSLAND FRUIT FLY.

The Governor in Council acting under section 9 of the Plant Health and Plant Products Act 1995 -

- (i) declares the area described in Schedule 1 to be a control area for the purpose of preventing the spread of Queensland fruit fly (*Bactrocera tryoni*); and
- (ii) prohibits the removal from the control area into any part of Victoria, any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Plant Health and Plant Products Regulations 1996, unless the fruit or vegetable is accompanied by a Plant Health Certificate or Plant Health Declaration and in the case of fruit for treatment, packing or processing outside the control area, is accompanied by a permit issued by an authorised officer; and
- (iii) requires owners and occupiers of land described in Schedule 2, which is within the control area, to give access to such land at all times to an authorised officer with or without assistants, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspection, placing on such land any lures or traps, applying on such land any spray material or bait and performing any other actions which in the opinion of the authorised officer are necessary for the eradication or prevention or spread of the pest; and
- (iv) requires owners and occupiers of land described in Schedule 2, which is within the control area, on instructions from an authorised officer, to strip fruit from trees, collect and dispose of waste fruit, or treat fruit and vegetables listed in Schedule 5 of the Plant Health and Plant Products Regulations 1996 in a manner approved by the Secretary; and
- (v) requires any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Plant Health and Plant Products Regulations 1996 which is transported through the control area, from areas free of Queensland fruit fly, to be transported in accordance with the conditions of a permit issued by an authorised officer.
