Electricity Industry Act 2000

Under sections 35(3) and 38 of the **Electricity Industry Act 2000** (as amended or replaced) and without prejudice to any other rights of CitiPower Pty ACN 064 651 056 ("CitiPower"), CitiPower gives notice that the existing tariffs applicable under sections 35 and 37 of that Act for certain customers of CitiPower will be varied. The varied tariffs will apply on and from 1 August 2001 until such time as the customer revokes their existing contract or enters into a new contract with CitiPower or other tariffs are determined and gazetted in accordance with section 35(3) or 38, as applicable, of the **Electricity Industry Act 2000** (as amended or replaced). To avoid doubt, the current tariffs (except for those to be varied as set out below) and the terms and conditions which apply to these customers under sections 35 and 37, respectively, of the **Electricity Industry Act 2000** will continue to apply without variation after that date.
