WILDLIFE (CONTROL OF HUNTING) NOTICE NO. 6/2001

I, Sherryl Garbutt, Minister for Environment and Conservation, make the following notice:

Wildlife (Control of Hunting) Notice No. 6/2001

1. Objective

The objective of this notice is to amend Wildlife (Control of Hunting) Notice No. 3/2001 and revoke Wildlife (Control of Hunting) Notice No. 5/2001 so as to revoke the prohibition against the taking, destroying and hunting specified taxa of duck in that part of Koorangie State Game Reserve known as Lake Bael Bael and Reedy Swamp.

2. Authorising provisions

This notice is made under section 86 of the Wildlife Act 1975 and section 27 of the Interpretation of Legislation Act 1984.

3. Commencement

This notice takes effect from Wednesday 9 May 2001.

4. Amendment of Wildlife (Control of Hunting) Notice No. 3/2001

In Wildlife (Control of Hunting) Notice No. 3/2001 (published in Government Gazette No. S27 on Saturday 17 March 2001, page 1) –

- (a) paragraph (b) of clause 4 headed 'Hunting of duck prohibited' is revoked;
- (b) Schedule 3 is revoked.

5. Revocation of Wildlife (Control of Hunting) Notice No. 5/2001

Wildlife (Control of Hunting) Notice No. 5/2001 (published in Government Gazette No. S37 on Saturday 24 March 2001) is revoked.
