MELBOURNE CITY COUNCIL ELECTIONS 2001 – SPECIFYING THE DATES

Order in Council

The Governor in Council acting under sections 3, 21, 21A and 22 of the **Local Government Act 1989** and section 13 of the **City of Melbourne Act 2001** orders that:

the dates for the general election for the Melbourne City Council shall be –

- 14 May 2001 Entitlement date for the purposes of Division 1 of Part 3 of the **Local Government Act 1989**;
- 18 May 2001 The date by which the Electoral Commissioner must supply to the Chief Executive Officer a voters' list for the purposes of section 21(2) of the **Local Government Act 1989**;
- 25 May 2001 The date by which the Chief Executive Officer must make out a voters' list for the purposes of section 22(2) of the **Local Government Act 1989**.
- 20 July 2001 The date for the holding of a general election for the purposes of section 13 of the **City of Melbourne Act 2001**.
