#### REGULATORY IMPACT STATEMENT

Juries (Fees, Remuneration and Allowances) Regulations 2001

A Regulatory Impact Statement has been prepared in relation to the proposed Juries (Fees, Remuneration and Allowances) Regulations 2001.

The proposed regulations re-enact the rates of remuneration for those attending for jury service and the existing fees payable by litigants requiring a civil jury trial that are presently fixed under the current regulations.

Those regulations lapse on the commencement of the **Juries Act 2000** at the end of July 2001.

Jurors remuneration rates are proposed to continue at \$36 per day for the first 6 days and then \$72 per day thereafter. After 12 months the rate increases to \$144 per day. Fees payable by litigants requiring a jury trial of a civil action continue to be fixed at \$455.

The impact statement examines alternative remuneration options and concludes that the existing levels should be continued until an assessment of the impact of changed jury profiles following the implementation of the **Juries Act 2000**. This will also allow further consideration of the Parliamentary Law Reform Committee's recommendation concerning jury remuneration.
