# **Subordinate Legislation Act 1994**

NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT

Water (Long Service Leave) Regulations 2001

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared for the Water (Long Service Leave) Regulations 2001.

The objective of the proposed Regulations is to prescribe long service leave arrangements and preserve the continuity of existing entitlements of officers of water authorities (other than councils and Catchment Management Authorities).

The RIS discusses possible alternatives to the proposed Regulations. These include relying on the **Long Service Leave Act 1992** or relying on a federal award or certified agreement provisions. The proposed Regulations were considered the best means of achieving the objective and the most appropriate method for managing long service leave in and between water authorities.
