ROAD SAFETY (VEHICLES) REGULATIONS 1999

Notice declaring Certain Rearloader Waste
Compactor Vehicles to be Class 3 Vehicles and
Specifying Dimension Limits

1. *Purposes*

The purposes of this Notice are—

- a. to declare certain rearloader waste compactor vehicles to be class 3 vehicles, and
- b. to specify dimension limits for those vehicles.

2. *Authorising Provisions*

This Notice is made by the Roads Corporation under—

- a. regulation 515 (2) of, and
- b. clause 40 of Schedule 3 to—

the Road Safety (Vehicles) Regulations 1999 (“the Regulations”) pursuant to a written Instrument of delegation dated 22 March 2001

3. *Commencement and period of operation*

This Notice—

- a. comes into effect on the day after it is published in the Government Gazette, and
- b. ceases to have effect on 1 July 2005.

4. *Declaration of rearloader waste compactor vehicles*

By this Notice, the Corporation declares the following category of vehicles to be class 3 vehicles for the purposes of the Regulations:

3 axle rearloader waste compactor motor vehicles fitted with a tandem axle group with 8 tyres, where—

- a. the rear overhang of the vehicle—
 - i. does not exceed 3.40 metres, and
 - ii. does not exceed 70% of the vehicle’s wheelbase;
- and
- b. the Corporation is satisfied that the vehicle—

- i. was registered in Victoria before 1 July 2001, or
- ii. was registered in another State or Territory before 1 July 2001, or
- iii. was ordered for manufacture before 1 July 2001.

5. *Specification of dimensions of rearloader waste compactor vehicles*

By this Notice, the Corporation specifies the following dimension limits for a vehicle in the category of vehicles declared to be class 3 vehicles by clause 4 of this Notice:

- a. The rear overhang of the vehicle—
 - i. must not exceed 3.40 metres, and
 - ii. must not exceed 70% of the vehicle’s wheelbase;
- and
- b. Otherwise, the dimension limits are the relevant dimension limits set out in Division 2 of Part 4 of the Regulations.
