## **BLF (De-recognition) Act 1985**

### SUPPLEMENTAL ORDER

The Governor in Council makes the following Order:

This is a Further Supplemental Order of the Order dated 13 October 1987 and published in the Government Gazette on 13 October 1987, made in pursuance of the powers conferred by section 7 of the **BLF (De-recognition) Act 1985** ("the Act"). The Governor in Council orders that:

1. In this Order a reference to:
  - (a) "the Custodian" is a reference to the Custodian, Stephen George Alley, appointed by the Order made under the Act on 20 August 1996; and
  - (b) "BLF" is a reference to BLF as defined in section 3 of the Act.

#### **Vesting Assets**

2. The Custodian may in writing vest in a person (including an organisation of employees registered under the **Workplace Relations Act 1996** (Cth)) any funds or property of BLF.
3. Any funds or property vested in a person under clause 2 thereafter shall cease to be funds or property of BLF and be owned by the person absolutely.
4. The Custodian may do all things necessary to effect any vesting of funds or property made under clause 2.
