Naming of Road Extending Off Maggios Rd, Barongarook


Notice is hereby given that the Colac Otway Shire on 27 June 2001 resolved to assign the name "Belsar Road" to an unmade portion of road extending south from Maggios Road, Barongarook.

The road in question is located about 0.9km east of the intersection of Maggios Road and Colac-Lavers Hill Road, Barongarook, between Nos. 40 and 100 Maggios Road and extends for a distance of approximately 350 metres.

This name was assigned after a process of public consultation in accordance with the provisions of the **Local Government Act 1989**.

The name shall take effect from the date of publication of this notice.

A Plan showing the location of the road is shown below.





Road Discontinuance/Exchange of land

Under Section 206 and Schedule 10, Clause 2 of the **Local Government Act 1989**, the Moorabool Shire Council discontinues that part of the Egerton–Ballark Road shown cross hatched (Lot C) on the plan hereunder and exchanges it for part of the land shown hatched (Lots A & B) on the plan.

Council has formed the opinion that the road deviation and resultant land exchange is necessary to correct an existing road alignment. The land exchange involves lands that are in the same ownership.

## Domestic (Feral & Nuisance) Animals Act 1994

Notice is hereby given that Council at its ordinary meeting held on 23 July 2001 resolved to make the following order under the provisions of section 26 of the **Domestic (Feral & Nuisance)** Animals Act 1994:

- 1. That the presence of dogs shall be prohibited in the following areas:
  - School grounds throughout the municipality;
  - Municipal swimming pools and surrounds;
  - Yarrawonga foreshore between Hunt Street/Bank Street and the waters edge, between Belmore Street and Woods Road; and
  - Thompson's Beach, Cobram the area between the pine post boundary along the access track and car park to the waters edge.
- 2. That dogs are permitted to be present in all other municipal places and public places only while fully constrained on a leash.
- 3. Clause 2 does not apply to the Showgrounds of the towns of Cobram, Nathalia, Numurkah and Yarrawonga, the football ground at Tungamah and other towns where dogs may be exercised off a leash in the presence of the owner during daylight hours only. This clause does not apply when an organised sporting event or similar activity is in progress, thereby allowing the presence of a dog on a leash only.
  - "Owner" has the same meaning as in the **Domestic (Feral & Nuisance) Animals Act 1994**.
- 4. That the Council order made on 16 December 1996 under the provisions of section 26 of the **Domestic (Feral & Nuisance) Animals Act 1994** be revoked.

Any person contravening this order is liable to a penalty of \$200 for the first offence and a penalty of \$400 for a second or subsequent offence.



Environment (Amendment) Local Law No. 13

## **ORDERS IN COUNCIL**

### Flora and Fauna Guarantee Act 1988

## FLORA AND FAUNA GUARANTEE (TAKING, TRADING IN AND KEEPING OF LISTED FISH) ORDER NO. 1/2001

The Governor in Council makes the following Order:

#### 1 Title

This Order may be cited as the Flora and Fauna Guarantee (Taking, Trading in and Keeping of Listed Fish) Order No. 1/2001.

### 2. Objective

The objective of this Order is to authorise the taking, trading in and keeping of fish that have been listed as threatened or which are members of communities that have been listed as threatened under the **Flora and Fauna Guarantee Act 1988**, subject to certain terms and conditions.

### 3. Authorising Provision

This Order is made under section 53(2) of the Flora and Fauna Guarantee Act 1988 and section 27 of the Interpretation of Legislation Act 1984.

#### 4. Revocation

The "Flora and Fauna Guarantee (Taking, Trading in and Keeping of Listed Fish) Order No. 1/2000" made on 22 August 2000 and published in Government Gazette G 34 on 24 August 2000 (pages 2163 to 2166) is **revoked**.

### 5. Definitions

In this Order-

"Act" means the Flora and Fauna Guarantee Act 1988;

"carcass" has the same meaning as in the Fisheries Regulations 1998;

"commercial aquarium" means an aquarium for which an aquaculture licence under section 43 of the **Fisheries Act 1995** is required;

"fish" has the same meaning as in the Fisheries Act 1995;

"inland waters" has the same meaning as in the Fisheries Act 1995;

"listed fish" means a fish which-

- (a) is included in the list of taxa and communities of flora and fauna which are threatened under section 10 of the Act; or
- (b) is a member of a community of fauna which is included in the list of flora and fauna which are threatened under section 10 of the Act;

"private aquarium" means an aquarium for which an aquaculture licence under section 43 of the **Fisheries Act 1995** is not required;

"Victorian waters" has the same meaning as in the Fisheries Act 1995.

# 6. Authority to take listed fish from or keep listed fish at an aquaculture operation or commercial aquarium

A person may take listed fish from an aquaculture operation or commercial aquarium or keep listed fish at an aquaculture operation or commercial aquarium subject to the following terms and conditions—

- (a) that she or he is—
  - (i) the holder of an aquaculture licence issued under section 43(2) of the **Fisheries Act 1995**; or
  - (ii) that she or he is acting on behalf of the holder of an aquaculture licence; and
- (b) that the taking or keeping of the listed fish is specified in the aquaculture licence.

## 7. Authority to keep listed fish in a private aquarium.

A person may keep listed fish in a private aquarium if she or he can provide documentary evidence that the listed fish were legally obtained.

## 8. Authority to take listed fish from or keep listed fish in a private dam or lake

A person may take listed fish from a dam or lake on private land or keep listed fish in a dam or lake on private land subject to the following terms and conditions—

- (a) that she or he can provide documentary evidence that the listed fish were legally obtained; and
- (b) that she or he is the holder of a permit issued under the **Fisheries Act 1995** that permits stocking of fish in private waters.

## 9. Authority to trade in listed fish

- (1) A person may trade in listed fish subject to the following terms and conditions—
  - (a) that she or he can provide documentary evidence that the listed fish were legally obtained; and
  - (b) in relation to Murray Cod, that the fish are not sold or offered for sale during the period of 1 September to 30 November in any year.
- (2) Despite sub-clause (1)(b), a person may sell fry, fingerlings or on-grown Murray Cod raised in an aquaculture operation authorised under section 43(2) of the **Fisheries Act 1995**, or legally obtained from outside Victoria.

## 10. Authority to take certain listed fish for the purpose of recreation

A person who is—

- (a) the holder of a recreational fishery licence issued under section 45 of the **Fisheries** Act 1995; or
- (b) exempt under section 47 of the **Fisheries Act 1995** from the requirement to hold a recreational fishing licence—

may take the listed fish specified in Column 1 of the Schedule to this Order subject to the terms and conditions specified in Column 2 of the Schedule.

## 11. Authority to take or keep certain listed fish for the purpose of commercial fishing

- (1) A person who is a holder of an access licence issued under section 38 of the **Fisheries**Act 1995 may take Freshwater Catfish, Golden Perch, Murray Cod, Silver Perch, and Bony Bream as a result of, or incidental to, the harvesting of non-listed fish, subject to—
  - (a) the terms and conditions of the access licence; and
  - (b) the terms and conditions specified in Column 2 of the Schedule which relate to size limits and closed seasons.
- (2) A person who is the holder of an access licence issued under section 38 of the **Fisheries Act 1995** may take or keep Flat-headed Gudgeon, Western Carp Gudgeon and Flat-headed Galaxias as part of a commercial bait collection operation, subject to the terms and conditions of the access licence.
