NOTICE OF VARIATION TO THE AGREEMENT FOR THE MELBOURNE CITY LINK PROJECT AND OF THE PUBLICATION OF "STATEMENT OF VARIATION No. 3/2001: RELEASE FROM SINGLE PURPOSE"

Notice is hereby given of a variation to the provisions of the Agreement for the Melbourne City Link Project ("the Agreement") made in accordance with the terms of that Agreement and section 15 of the **Melbourne City Link Act 1995**.

The variation consists of the execution of the letter from Transurban City Link Limited ("Transurban") relating to "Release from Single Purpose" dated 19 September 2001 ("Release from Single Purpose Letter").

The Release from Single Purpose Letter establishes the framework for the State's consent to the Transurban proposed restructure and after the restructure to enable the restructured vehicles to pursue new businesses free of the single purpose entity constraint.

The variation comes into operation on the date this notice is published in the Government Gazette.

The Statement of the Variation (called "Statement of Variation No. 3/2001: Release from Single Purpose") may be inspected free of charge during office hours at:
