HOMICIDE OF JANE THURGOOD-DOVE \$100,000 Reward

The co-operation of the public is being sought to establish the identity of the person, or persons, responsible for the death of Jane THURGOOD-DOVE. She died as a result of injuries received after being shot in the driveway of her home at 5 Muriel Street, Niddrie, on 6 November 1997.







WHITTLESEA CITY COUNCIL

General (Amendment) Local Law No. 1 of 2001

At its meeting on 18 September 2001 Council resolved to make the above Local Law commencing 1 October 2001 for the purposes of assisting Council in responding to community issues and further protecting community amenity and the overall appearance of the municipal district as follows:

Refuse Collection

Clause 5.12 addresses the use, placement or care of mobile garbage bins for residential premises and some business premises.

Placement/Removal of Garbage/Recycling Receptacles

Clause 5.16 of the new Local Law makes it an offence to take out garbage/recycling receptacles for emptying before 4.00 p.m. on the day prior to the scheduled day of collection or leaving a receptacle out beyond the same day it is emptied.

Recycling, Hard/Green Waste Collection

Clause 5.17 of the new Local Law addresses these concerns and makes it an offence to take out recycling or hard/green waste more than 48 hours before a collection.

Trade Waste Hoppers

Clauses 5.18 to 5.20 regulate the use of trade waste hoppers. Authority is included for Council to impound offending equipment.

Clothing Bins

Clause 9.1 requires a permit for charity bins to be placed on private land, where such bins are visible from public places. The issue of permits will enable Council to minimise detrimental impact on community amenity caused by dumping of material around bins and graffiti on bins.

Property Numbers

Clause 10.2 clarifies the requirements for property numbering to ensure that property numbers are clearly visible from the street. These requirements will include size of the number, contrasting background, the distance at which a number must be readable and property numbering of premises over 0.8 hectares in area.

Advertising Signs

Clause 13.3 provides authorised officers with the power to impound illegally placed signs, particularly in cases where the owner of the sign cannot be contacted to arrange removal.

Fencing of Vacant Land

Clause 10.7 addresses resident concerns regarding rubbish dumping on private vacant land and requires property owners to take reasonable steps to prevent or reduce the occurrence of dumping on their land.

Incinerators and Open Fires

Clause 4.3 has been revised to clearly state that the lighting of fires for the purpose of cooking food for human consumption must be in a barbecue.

Impounding

Clause 2.12 allows a Notice of Impounding to be served either on the person contravening the Local Law or on the owner of the item being impounded. It also makes provision for an impounded item to be disposed of if it is not claimed within the required time.

1. 5 knot speed limit for the purposes of Clause 7.

All the waters of the Yarra River upstream of the Designated Port of Port Phillip are subject to a speed limit of 5 knots.

2. Areas prohibited to vessels for the purposes of Clause 9.

The waters of the Yarra River beneath the southern most arch of the footbridge at Southbank between Princes Bridge and the Sandridge Railway Bridge are prohibited to vessels.

- 3. Prohibition of Specified Activities for the purposes of Clause 12.
 - (a) The waters of the Yarra River upstream of the designated Port of Port Phillip to the Gipps Street Bridge (Collins Bridge) are prohibited to swimmers.



 - (a) the Corporation receives written notification from the Treasurer of the State of Victoria that
 - (i) Marstel Terminals Coode Island Pty Ltd has failed to enter into a Grant Deed with the State of Victoria which would have entitled Marstel Terminals Coode Island Pty Ltd to State assistance for undertaking a bulk liquid terminal development on the Relevant Land; or
 - (ii) such a Grant Deed has been terminated; or

MARINE (AMENDMENT) REGULATIONS 2001

In accordance with the provisions of section 11 of the **Subordinate Legislation Act 1994**, notice is given of the availability for public comment of the proposed Marine (Amendment) Regulations 2001 and Regulatory Impact Statement (RIS).

The proposed regulations are authorised under sections 105, 108, 116, 117, 118, 119, 120 and 125 of the **Marine Act 1988**.

The objectives of the proposed regulations are to –

- a) prescribe additional requirements for certain vessels in relation to certificates of survey;
- b) provide for operator licences in respect of regulated recreational vessels; and
- c) provide for endorsements on operator licences in respect of personal watercraft endorsements; and
- d) prescribe fees to be charged in relation to operator licenses and personal watercraft endorsements; and
- e) prescribe particulars for notices relating to offences involving alcohol or other drugs;
- f) prescribe additional offences for which marine infringement notices can be issued; and
- g) provide for other matters as authorised by the Marine Act 1988.

The proposed regulations add new provisions to existing regulations and, in order to enhance safety outcomes on State waters, will require all operators of mechanically powered recreational boats to be licensed. To obtain a licence, applicants will need to demonstrate awareness of safe operator practices and relevant marine laws. Licence holders will be readily identifiable for law enforcement and investigation of marine incidents. Persons who are, or become, unsuited to operate mechanically powered recreational boats will not be permitted to do so. Further provisions are introduced in relation to the immediate suspension of licences for alcohol, drug and other offences. Certificates of survey must also be carried and displayed on all relevant commercial vessels.

The RIS has been prepared in consultation with the Marine Board of Victoria. It identifies the likely impact of the proposed regulations, assesses their costs and benefits and considers alternative methods of achieving the identified objectives. The RIS concludes that the overall benefits to the community outweigh the costs imposed by the proposed regulations.

Amendment VC13

The Minister for Planning has approved Amendment VC13 to the Victoria Planning Provisions.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- Amends the user Guide.
- Amends Clauses 16 and 17 of the State Planning Framework to require planning and responsible authorities to have regard to the Victorian Code for Broiler Farms when considering proposals for broiler farms or residential development near broiler farms.
- Introduces 'Broiler farm' as a land use term in the Definitions.
- Introduces a permit-requirement for Broiler farm in the Rural zone.
- Introduces a new Particular provision applying to land used and developed or proposed to be used or developed for a Broiler farm.
- Amends the Schedule to Clause 81 of all planning schemes to include the Victorian Code for Broiler Farms as an incorporated document and the Local Planning Policy Frameworks of 11 planning schemes to achieve consistency with the new code and Broiler farm Particular provision.
- Amends the advertising sign controls in Category 3 (High amenity areas) to enable permit applications to be made for business logo and street number signs on buildings higher than 10 metres.
- Deletes references to sign content in decision guidelines for major promotion sign applications and introduces a mandatory permit condition to ensure that changes in the content of major promotion signs meet road safety considerations.
- Updates references in the Environmental Audit Overlay to amended sections of the Environment Protection Act 1970, following amendments to that Act.
- Exempts domestic rainwater tanks of 4500 litres or less from permit requirements except in the Heritage Overlay.
- Corrects errors created by the introduction of Amendment VC12 by reintroducing 'Animal keeping' in the Residential 1 Zone table of uses and reintroducing the ability to designate areas in the schedule to Business 1 Zone where a permit is required for 'Restaurant'.


