**Schedule**

**1. Amendment to rule 15**

After rule 15.13, **insert**—

15.14 If during the course of play it is found that the deck/s in play do not contain the correct cards used to form the approved deck/s for the particular version of Blackjack in play:

15.14.1 The result of any rounds of play previously completed shall stand;

15.14.2 The round of play where the error is discovered shall be declared void and all monies returned for that round of play; and

15.14.3 The remainder of the shoe shall be declared void and the cards removed from play.

**2. Amendment to rule 22.3.1**

For rule 22.3.1, **substitute**—

22.3.1 “Crown Pontoon” shall be played with four to eight decks of 48 cards having had the four tens removed i.e. Ten of Hearts, Diamonds, Clubs and Spades.

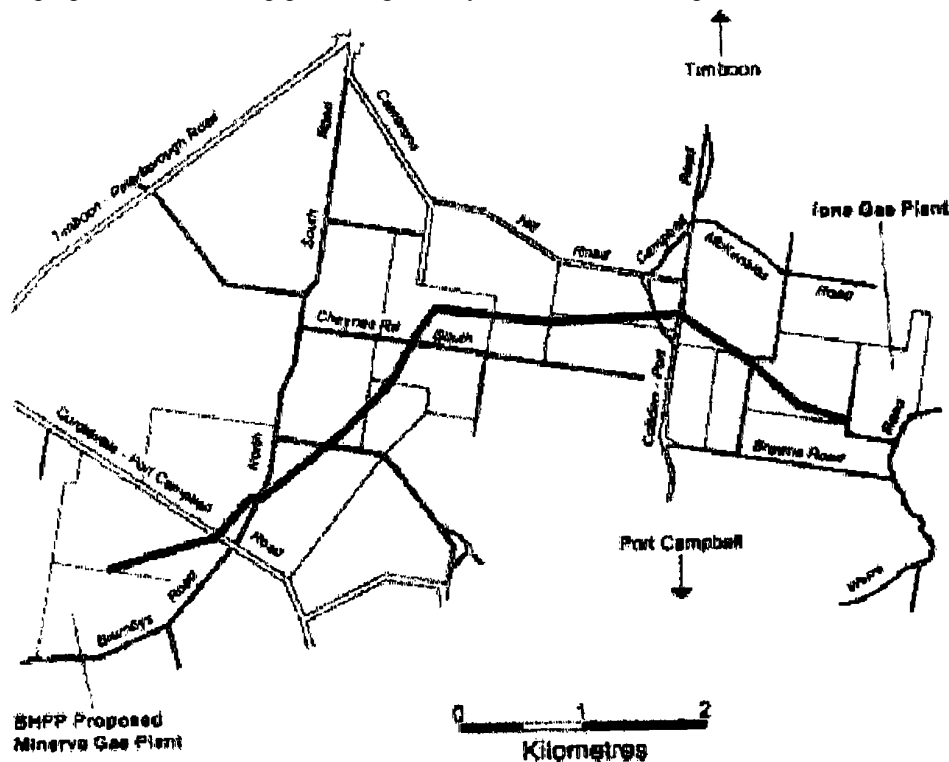

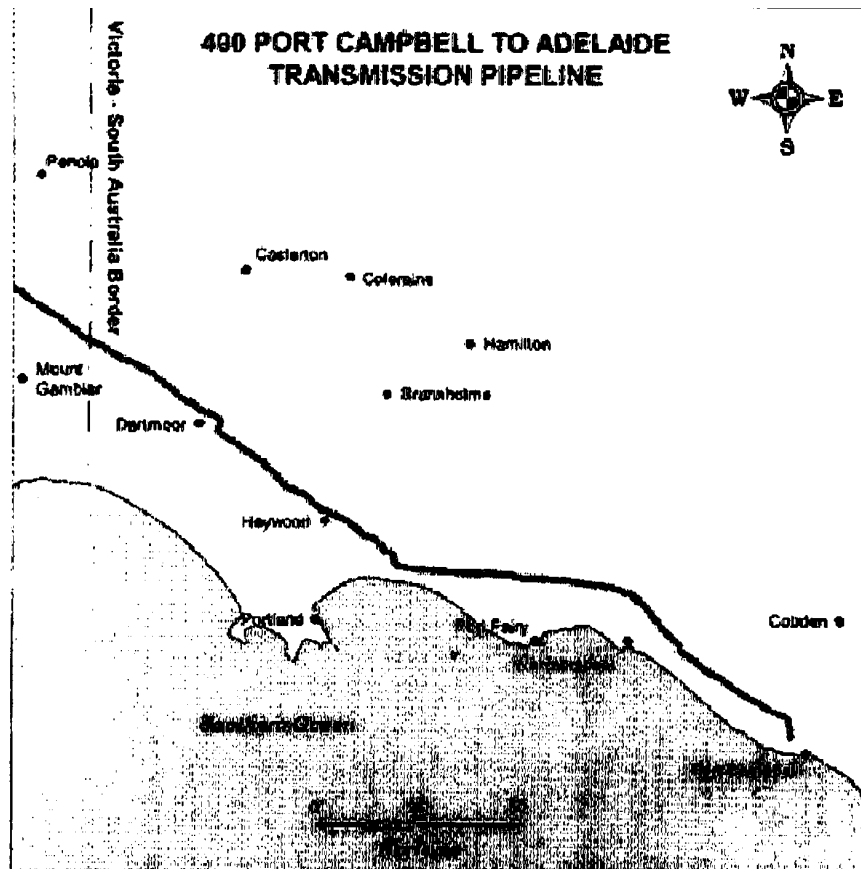
