## Melbourne City Link Act 1995

### ORDER APPROVING PURPOSES AND GRANTING LEASES

1. The Governor in Council, under section 60(1) of the **Melbourne City Link Act 1995**, approves the purposes of—
  - (a) construction and use of a carpark and landscaping (including construction and planting) and use of the landscaped land in respect of—
    - (i) the following Company Leases—  
Southern Link Section 5  
Southern Link Section 1  
Tullamarine Freeway Upgrade and Western Link Section 1
    - (ii) the following Trust Concurrent Leases—  
Southern Link Section 5  
Southern Link Section 1  
Tullamarine Freeway Upgrade and Western Link Section 1
    - (iii) the following Trust Leases—  
Southern Link Section 5  
Southern Link Section 1
  - (b) the construction and use of an operations centre and offices for the purposes of the Project and the Exhibition Street Extension Project (each as described in the **Melbourne City Link Act 1995**) and the purposes of commercial tenancy, in respect of the Burnley Office Site Lease.
2. The Governor in Council grants —
  - (a) under section 60(1) of the **Melbourne City Link Act 1995**, subject to and in accordance with the Agreement (as defined in the **Melbourne City Link Act 1995**), to the person or persons entitled to such leases in accordance with the Agreement —
    - (i) each of the Leases referred to in paragraph 1(a)(i), 1(a)(ii) and 1(a)(iii) for the purposes identified in those paragraphs and the purpose of managing the roadway and ancillary works constructed on the land;
    - (ii) each of the leases referred to paragraphs (A), (B) and (C) below for the purpose of managing the roadway and ancillary works constructed on the land—
      - (A) The following Company Leases —  
Western Link Section 2  
Southern Link Section 2  
Southern Link Section 3  
Southern Link Section 4
      - (B) the following Trust Concurrent Leases—  
Western Link Section 2  
Southern Link Section 2  
Southern Link Section 3  
Southern Link Section 4
      - (C) the following Trust Lease—  
Tullamarine Freeway Upgrade and Western Link Section 1

- (b) under section 93G(1) of the **Melbourne City Link Act 1995**, subject to and in accordance with the Extension Agreement (as defined in the **Melbourne City Link Act 1995**), the Exhibition Street Extension Lease (the ESEP Lease), to the person or persons entitled to such lease in accordance with the terms of that Agreement.
