PROPOSED ENVIRONMENT PROTECTION (DISTRIBUTION OF LANDFILL LEVY) REGULATIONS 2002

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** of the proposed making of the Environment Protection (Distribution of Landfill Levy) Regulations 2002.

The objective of the proposed regulations, which are to be made under the **Environment Protection Act 1970** (the Act), is to specify how landfill levies are to be distributed for the purposes of section 70(6B) of the Act. The

proposed regulations would distribute funds arising from levies on municipal and industrial waste between the key state government bodies responsible for planning for and managing waste in Victoria, namely regional waste management groups, EcoRecycle Victoria and EPA Victoria.

A Regulatory Impact Statement has been prepared in accordance with the requirements of the **Subordinate Legislation Act 1994**.

The Regulatory Impact Statement concludes that the proposed statutory rule would ensure the key bodies receive sufficient funding to meet their statutory functions under the Act, provide certainty and transparency to enable confident planning, and ensure an adequate flow of funds to a new sustainability fund for priority projects and initiatives. The proposed statutory rule would therefore help deliver on Government commitments to improve resource use efficiency and waste management in Victoria. The Regulatory Impact Statement concludes that the benefits of making the proposed regulations outweigh the associated costs.

Prescribed Industrial Waste Classification

- 1. For the purpose of clause 11(1) and in accordance with Schedule 1 of the industrial waste management policy (Prescribed Industrial Waste) the Authority hereby classifies certain types of designated contaminated soil in terms of opportunities for its reuse, recycling, recovery of energy and treatment as shown in Table 1.
- 2. The classification applies to contaminated soils (other than contaminated soils (low level)) prescribed in Schedule 1 of the Environment Protection (Prescribed Waste) Regulations 1998, contaminated with the stated contaminant types as specified in Table 1 below.
- 3. This classification will come into effect upon publication in the Government Gazette.

Sports Event Ticketing (Fair Access) Act 2002

MINISTER'S GUIDELINE

AUTHORISATION OF NOMINATING AUTHORITIES

I, Justin Madden, Minister for Sport and Recreation issue the following Guideline under Part 4 of the **Sports Event Ticketing (Fair Access) Act 2002** ("the Act") which provides that an event organiser must within 60 days after receiving notice that the Minister has declared an event for the purposes of the Act, give the Minister a ticket scheme proposal. The proposal must comply with these guidelines.

The Minister may require the event organiser to provide further details of the proposal within a specified time, may extend the time for providing a proposal or extend the time for providing further details of a proposal.

An event organiser may, with the Minister's written approval, give the Minister a replacement ticket scheme proposal at any time before receiving notice from the Minister that:

- the ticket scheme set out in the original proposal is an approved ticket scheme; or
- otherwise that the Minister has refused to approve the ticket scheme set out in the original proposal.

Guidelines – Information requirements (the questions)

The Guidelines are a series of questions which when answered are designed to provide the Minister with the detail necessary to permit informed consideration of the proposals.

Attachments and ancillary documentation may be provided but should not be submitted in lieu of a detailed specific response to relevant questions.

The guideline questions are grouped under the following categories:

- A. Event Identification
- B. Ticket Allocation
- C. Control of Tickets
- D. Sale and Distribution of Tickets
- E. Industry Codes and Standards

All sections and questions must be completed.

Questions considered "not applicable" must be clarified with a brief explanation.

All information which is deemed as commercially sensitive (commercial in confidence) or where there are personal privacy considerations must be clearly identified.

A. Event Identification

When answering the following questions relating to the description and timing of the event and event venue, the applicant should provide the fullest possible response and a level of detail necessary to permit informed consideration for the proposal. The applicant must include:

- (a) What is the formal name of the event?
- (b) Under what other name(s) is the event proposed to be promoted?

Notes:

An event may have a formal name, but be promoted under other descriptions.

- (a) What is the date(s) of the event?
- (b) At what venue(s) will the event be held?

Notes

An event may be held over a number of days, eg, the Australian Tennis Open, and, at a number of venues.

B. Ticket Allocation

The specified minimum proportion of tickets available for sales or distribution to the public generally or to particular classes of persons should be answered by the following questions:

(a) What proportion of all seats in the venue is specified as being available for the sale or distribution of tickets to the general public?

Notes:

- (i) Information should be provided of the total number of seats at the venue for the event and the percentage number of that total available for sale or distribution to the public.
- (ii) A distinction is made between "sale", being the purchase of tickets, and, "distribution", being tickets made available at no cost or as part of a promotional initiative, eg a prize in a competition.
- (b) What proportion of all seats in the venue is specified as being available for the sale or distribution of tickets to a particular class, or classes, of persons?

Notes:

- (i) Information should be provided of the total number of seats at the venue for the event (ie, how many can be admitted irrespective of whether or not paying admission) and the percentage number of that total available for sale or distribution to a particular class, or classes of, persons.
- (ii) A distinction is made between "sale", being the purchase of tickets, and, "distribution", being tickets made available at no cost or as part of a promotional initiative, eg a prize in a competition.
- (iii) A particular class, or particular classes, of persons should be understood to include members of a club affiliated with the event.

Example: In the case of the AFL Grand Final the particular classes may be the members of the competing clubs, the members of the non-competing clubs, AFL members and Melbourne Cricket Club members.

(c) What is the breakdown of tickets allocated otherwise than by sale and distribution to the general public or to a particular class, or classes, of persons?

Notes:

Information should be provided of such tickets allocated, including other entry authority if not admitted by ticket (eg, media passes, other complimentary passes, competitions, charity auctions, contra arrangements).

(d) How is the venue to be configured to ensure the objective of a fair process, maximising public access to the venue?

Notes:

Information should be provided that demonstrates that the venue is configured to enable fair public access. Re-configuration of a venue to substantially emphasise corporate accommodation would not be consistent with fair public access.

C. Control of Tickets

Answers to the following questions will be taken into account in considering the process for tracing the ultimate use made of a ticket:

- (a) What steps will be taken to ensure that a person authorised to sell or distribute tickets to the event is aware of the obligations imposed on the event organiser under the Act?
- (b) What steps will be taken to ensure that a person authorised to sell or distribute tickets to the event is aware of the obligations imposed on him or her under the Act?

Notes:

- (i) Part 5 of the Sports Event Ticketing (Fair Access) Act provides that it is an offence:
 - for the event organiser, without reasonable excuse to sell, or authorise the sale of, tickets or conduct the event in the absence of the Minister's approval;
 - if the event organiser knowingly fails to comply with the approved ticket scheme for the event;
 - if the event organiser fails to ensure that a person authorised in writing to sell or distribute tickets to the event on behalf of the event organiser does so in accordance with the approved ticket scheme for the event;
 - if such an authorised person, without reasonable excuse, sells or distributes tickets otherwise than in accordance with the approved ticket scheme for the event;
 - for a person to engage in ticket scalping.
- (ii) Steps that may be considered would be to include in the event organiser's contract with the authorised ticket seller/distributor:
 - specific references to the statutory obligations;
 - compensation provisions for the event organiser where the authorised seller/distributor breaches the statutory obligations (perhaps set at a level commensurate with the penalties under the Act);

conduct information/training seminars with the authorised seller/distributor.

- (c) Who will be authorised to sell and/or distribute tickets to the event?
- (d) What arrangements are in place to monitor the sub-contracting of sale and distribution of tickets?

Notes:

- (i) Information should be provided demonstrating the breakdown of tickets available to be sold or distributed direct to the public or others by the event organiser.
- (ii) Similarly, there should be a breakdown of tickets allocated for sale or distribution by entities other than the event organiser (eg, Ticketmaster, AFL clubs, tourism agencies including airlines, promotional agencies including media, such as radio stations).
- (e) What specific measures are proposed or implemented to ensure that the above breakdowns will result in achieving the objective of a fair process, maximising public access to the event?

Notes:

- (i) Information should be provided of arrangements made by the event organiser to ensure that those agencies or entities selling or distributing tickets do so in accordance with the objective.
- (ii) Perhaps one measure may be a condition in the contractual or licensing arrangements between the event organiser and the selling/distributing agencies or entities. Such a condition may impose a penalty reasonably corresponding to any penalty incurred by the event organiser for a contravention of the legislation where that contravention resulted from the action of those agencies or entities.
- (f) What arrangements are proposed for recording allocation of individual tickets or batches of tickets?

Notes:

- Measures that might be taken include the numbering of tickets and colour coded tickets.
- (g) What arrangements are proposed for the return of unwanted tickets?

Notes:

- (i) The focus here is on the extent to which the distribution of the tickets is being accounted for. Full transparency is sought from the event organiser. Under these guidelines the event organiser should provide information on the following:
 - 1. Numbered tickets.
 - 2. Specify where each ticket is going. For example, tickets 1–10,000 sold through ticket agency to general public. Tickets 10,000–15,000 given to Sponsors. Tickets 15,000–16,000 sold through packaged deals. Tickets 16,000 to 17,000 used in house by event organisers.
 - 3. Arrangements for seeking similar diligence and disclosure from its sponsors and agents in their allocation.
 - 4. Non-Transferable tickets. Tickets made null and void if sold to a third party (similar to existing rules on AFL Membership tickets).
 - 5. The measures to be implemented to enable ticket purchasers to clearly identify authorised ticket sellers/distributors.

The information required for the conditions on tickets to prevent ticket scalping is obtained by answering this question:

(a) What arrangements are proposed to ensure that individuals don't buy a large number of tickets to later re-sell (ticket scalping)?

Notes:

- (i) Consistent with the objective of fair access to tickets, information should be provided on proposals to limit the number of tickets available for purchase by an individual (including a corporate entity), eg, where a limit of one order per individual is imposed.
- (ii) Information should be provided of any conditions on the ticket concerning resale or transfer of tickets. For example, such a condition may stipulate that tickets must not be resold or transferred, used in lotteries or competitions, included in travel or hospitality packages, handled in any way which conflicts with any event organiser sponsorship or commercial arrangements or dealt with in any way whatsoever which is not in accordance with private use. By way of example, the conditions of sale appearing on Australian Rugby Union tickets reads as follows: It is a condition of sale that this ticket may not, without prior written consent of the ARU, be resold at a premium nor used for advertising, promotion or other commercial purposes (including competitions or trade promotions) or to enhance the demand for other goods or services. If a ticket is sold or used in breach of this condition, the bearer of the ticket will be denied admission."

D Sale and Distribution of Tickets

The ticket purchasing arrangements should be outlined by answering the following questions:

(a) What is the method(s) for purchasing tickets?

Notes:

 Some major sporting events have, in effect, a public lottery process, such as the Sydney 2000 Olympics.

- (b) Can tickets be purchased in person?
- (c) Can tickets be purchased as a group?
- (d) Can tickets be purchased by order made by telephone?
- (e) What arrangements are there to order tickets online?

Notes:

- (i) Information should be provided of how a sale made by telephone or online is validated.
- (f) Will decentralised arrangements be made for purchase of tickets?

Notes:

- (i) Information should be provided on the number (if limited) of tickets available for purchase at decentralised outlets and the location of such outlets.
- (g) What is the timeframe for the release of tickets for sale at all outlets and purchase modes?

Notes:

- (i) Information should be provided on the timeframe for the sale and distribution of tickets.
- (h) What arrangements are proposed for tickets with special seating for disabled patrons?

Notes:

- Information should be provided of arrangements for wheelchair spaces (with companion seats) and easy access seats for use by disabled spectators.
- (i) Who should a purchaser contact with questions about access to tickets?
- (j) What arrangements are proposed for dealing with complaints?

Notes:

- (i) Details should be provided of the processes for resolution of complaints.
- (k) Are measures proposed to prevent ticket fraud (eg, ticket forgery, internet ticket scams)?

Notes:

(i) It might be expected that security measures would be incorporated into the tickets. Specific details need not be provided where disclosure of such information would be reasonably likely to jeopardise the integrity of the security measures.

The applicant is required to answer the following question relating to the public awareness of all authorised tickets sale and distribution arrangements:

(a) What strategies are proposed to ensure that the general public is aware of the arrangements for the sale and distribution of tickets?

Notes:

- (i) A fundamental principle underpinning the statutory requirements is that there should be transparency. A person wishing to seek tickets to the event should have ready access to all information relating to access to tickets. Similarly a person seeking tickets should be able to readily ascertain the authority of the organisation/agency to offer to sell and/or distribute tickets to the event.
- (ii) Information may be provided on the publicity and promotional arrangements of the event.

E Industry Codes and Standards

The required industry codes and standards information is be given by the answering the following question:

(a) Does the ticketing scheme comply with any existing industry codes/best practice for event ticketing?

Notes:

- (i) Industry codes may be developed for event ticketing covering a number of matters not included in these guidelines, such as sight-lines, refund policy, etc.
- (ii) It is expected that the ticketing scheme will comply with any accepted "best practice" ticketing standards, and therefore, reflect or improve upon current industry standards.





 - (i) by heavy black delineation on Plan S-1525/1; and
 - (ii) where any boundary is formed by a roadway reserve, the boundary is situated in the centre of the road for the time being on that roadway reserve.


