### **CENTRAL GOLDFIELDS PLANNING SCHEME**

#### **Notice of Approval of Amendment**

#### **Amendment C3**

The Minister for Planning has approved Amendment C3 to the Central Goldfields Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment provides for the development of a new Police Station at Maryborough and the construction of a new area of public car parking. The Amendment:

- a) rezones Crown Allotments 12 and 13, and Part 11 Parish of Maryborough from Public Use (6) (Local Government) to Public Use (7) (Other); and
- b) rezones Crown Allotment 15 and Part 3, Section 27, Parish of Maryborough from Business 2 Zone and Residential 1 Zone to Public Use Zone (6) (Local Government).
