Notice of Approval of Amendment

Amendment VC17

The Minister for Planning has approved Amendment VC17 to the Victoria Planning Provisions.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- Amends the Public Acquisition Overlay in the Victoria Planning Provisions and corresponding planning schemes to provide exemption from the permit requirement for proposals that are consistent with the purpose for which the land was or is to be acquired.
- Provides permit exemptions and introduces an incorporated document for 3 Rail Infrastructure Projects (Rail Gauge Standardisation Project, Regional Fast Rail Project and Fibre Optic Project) in the Ballarat Planning Scheme, Baw Baw Planning Scheme, Brimbank Planning Scheme, Buloke Planning Scheme, Cardinia Planning Scheme, Central Goldfields Planning Scheme, Gannawarra Planning Scheme, Golden Plains Planning Scheme, Greater Bendigo Planning Scheme, Greater Geelong Planning Scheme, Hepburn Planning Scheme, Hume Planning Scheme, Latrobe Planning Scheme, Loddon Planning Macedon Ranges Scheme, Planning Scheme, Melton Planning Scheme, Mildura Planning Scheme, Moorabool Planning Scheme, Mount Alexander Planning Scheme, Northern Grampians Planning Scheme, Swan Hill Planning Scheme, Wvndham Planning Scheme and Yarriambiack Planning Scheme.
