- The Forum for Islamic women provides an opportunity for Islamic women to explain

the custom and meaning of dress in cultural and religious terms. This event is aimed at demystifying Islamic culture to Australians and building bridges of understanding in the community.

- The applicant is working with refugees from Islamic cultures within the municipality and this forum is one of a number of community building activities aimed at facilitating their resettlement and encouraging diversity and equity in our community.
- The event will be a fashion parade by young Muslim women and an explanation of the position of women in Islamic cultures.
- The fashion parade will feature Muslim women veiled and unveiled and wearing make-up as part of the cultural tableau. This cannot happen in the presence of men.

The Tribunal hereby grants an exemption to the applicant from the operation of Sections 42 and 195 of the **Equal Opportunity Act 1995** to enable the applicant to advertise and hold a women only function to meet and relate to Muslim women.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 13 February 2005.

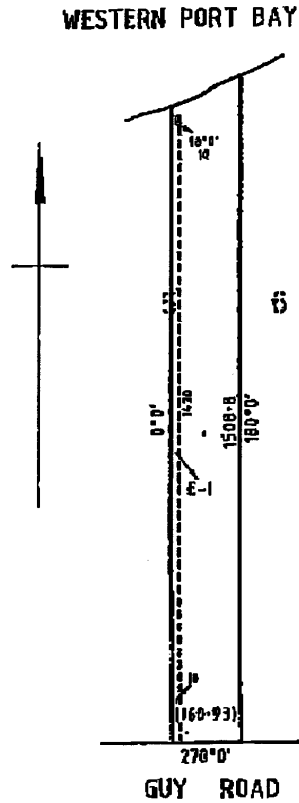

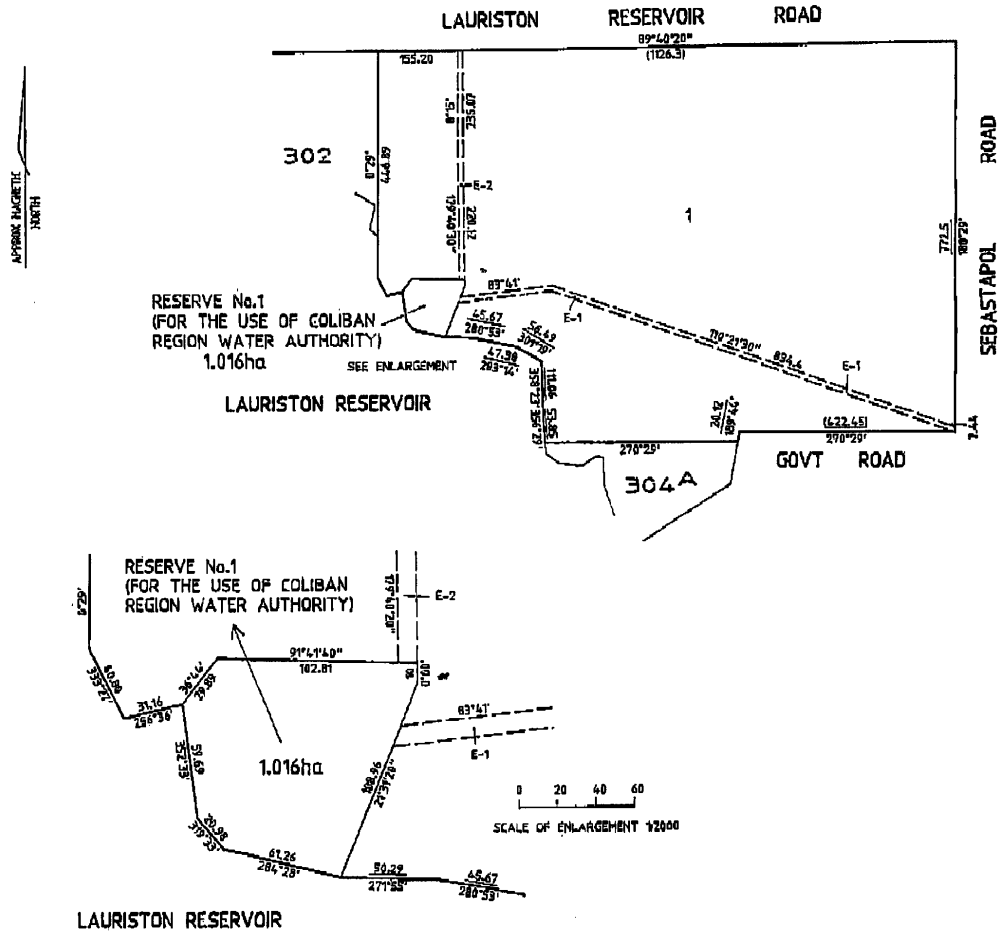

 (Green Hill Lake – Ararat Rural City Council)

1. For Schedule 54 to Notice No.1 substitute –

**“SCHEDULE 54
WATERS-GREEN HILL LAKE**

Local Authority – Ararat Rural City Council

1. Access lane for the purpose of Clause 5.
The waters of Green Hill Lake extending 30 metres from the edge of the water for the time being in an area approximately 180 metres wide and situated between two points approximately 200 metres and 380 metres east of the spillway on the highwater line of the southern bank are an access lane.
2. 5 Knot speed restriction zones for the purpose of Clause 7.
 - (a) All the waters of Green Hill Lake are subject to a speed limit of 5 knots, excluding the waters within the area bounded by a sign (No. 1) on the southern shore 380 metres east of the spillway to a yellow buoy (No. 2) 50 metres south-west of the island situated in the south-east corner of the Lake thence north-westerly to a yellow buoy (No. 3) 50 metres west of the north-west corner of Lake Island thence due west to a yellow buoy (No. 4) 150 metres from the north-west corner of Lake Island and thence south-westerly to a yellow buoy (No. 5) 360 metres north of the spillway on the high water line of the western bank of the lake and thence following the boundary of the 5 knot zone within 30 metres of the shore and the boundary of the prohibited zone Clause 3a of this schedule.
 - (b) All the waters of Green Hill Lake are subject to a 5 knot speed limit between sunset and sunrise.
3. Areas prohibited to vessels for the purpose of Clause 9.
The waters of Green Hill Lake
 - (a) adjacent to the spillway near the south-west corner of the lake commencing at a point approximately 150 metres north of the spillway at the high water line of the western bank to a point marked by a red buoy being approximately 80 metres directly east of the middle of the spillway to a point approximately 230 metres east of the spillway on the high water line of the southern bank;
 - (b) in the swimming area located in the area bounded by the southern point of the island which is due west of the eastern swimming beach thence south-easterly to a point on the high water line on the lake shore thence northerly along the shore line to a point due north of the island which is west of the eastern swimming beach thence to a point on the northern tip of the island which is due west of the eastern swimming beach and thence along the high water line of the eastern shore line of the island which is west of the eastern swimming beach to the commencement point are prohibited to vessels.
4. Exclusive use and special Purpose area for the purposes of Clause 13.
The waters of Green Hill Lake described in item 2(a) of this schedule are subject to the following vessel operating conditions –
 - (a) There must be no more than 5 vessels involved with waterskiing in the area at any one time;
 - (b) No more than 5 circuits or 20 minutes continuous operation for any vessel involved with waterskiing is permitted whilst another vessel is waiting in the access lane for a turn to operate;
 - (c) Vessels involved with waterskiing must complete an entire circuit before re-entering the access lane and must not stop except for the purpose of assisting a water skier or another person in the water, or where for emergency reasons it is not practicable to complete a circuit.

5. Revocation of amending Notice.

Unless the Ararat Rural City Council recommends the continuation of these rules the notice making Schedule 54 is revoked 18 months after the date of publication in the Government Gazette (14 February 2002) and the rules in force preceding that date are reinstated.”

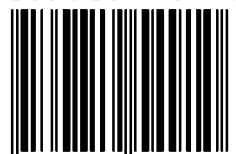
