The Minister for Planning has approved Amendment C18 to the Kingston Planning Scheme.

Amendment C37

The Minister for Planning has approved Amendment C37 to the Mornington Peninsula Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment introduces a number of minor changes of an editing nature affecting twenty one (21) heritage places within the Planning Scheme. The Amendment corrects and updates descriptions and map delineations of the heritage places due to recent locality changes in the municipality, the introduction of street

numbers and to recognise recent additions to the Victorian Heritage Register. A number of inconsequential changes have been made to the Schedule of the Heritage Overlay, but not to affect the intent of the Scheme as previously operating.
