INDIGO PLANNING SCHEME Notice of Approval of Amendment Amendment C13

The Minister for Planning has approved Amendment C13 to the Indigo Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones the subject land comprising of Crown Allotments 5 and Part of 7, Section A1 being part of the Wangaratta Farm Penal Purposes Reserve (WFPPR) from a Public Conservation and Resource Zone to a Special Use Zone.
