## Wildlife Act 1975

### WILDLIFE (CONTROL OF HUNTING) NOTICE No. 2/2002

I, Sherryl Garbutt, Minister for Environment and Conservation, make the following Notice:

#### Wildlife (Control of Hunting) Notice No. 2/2002

1. **Title**

This Notice may be cited as the Wildlife (Control of Hunting) Notice No. 2/2002.

2. **Objective**

The objective of this Notice is to prohibit the taking, destroying and hunting of the taxa of duck specified in Schedule 1 in the areas of Victoria specified in Schedules 2 and 3 during the period commencing on Saturday 16 March 2002 and ending on Monday 10 June 2002 (both dates inclusive).

3. **Authorising provision**

This notice is made under section 86 of the **Wildlife Act 1975**.

4. **Hunting of duck prohibited**

The taking, destroying or hunting of the taxa of duck specified in Schedule 1 is prohibited –

(a) in the area described in Schedule 2; and

(b) in the area described in Schedule 3 –

during the period commencing on Saturday 16 March 2002 and ending on Monday 10 June 2002 (both dates inclusive).

5. **Contravention of Notice**

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
