Country Fire Authority Act 1958

VARIATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by Section 4 of the **Country Fire Authority Act 1958**, I, Robert Gordon Seiffert, Chief Executive Officer of the Country Fire Authority, after consultation with the Secretary of Natural Resources and Environment, hereby vary the declaration of Fire Danger Periods previously published in the Government Gazette by declaring that such Fire Danger Periods shall end in respect of the undermentioned Municipal Districts of Municipalities or parts of Municipalities specified.

To terminate from 01.00 hours on 15 April 2002:

Shire of Moira, City of Greater Shepparton, Alpine Shire Council, Indigo Shire Council, Towong Shire Council, Wodonga Rural City, Rural City of Wangaratta, Central Goldfields Shire Council, Hepburn Shire Council, Ballarat City Council, Golden Plains Shire Council, West Wimmera Shire Council (Part) That part north of the line described by the southern boundaries of the following Parishes: Tallageira, Booroopki, Morea, Dopewara, Karnak & Kalingur, Shire of Golden Plains, Macedon Ranges Shire Council, Shire of Campaspe, Northern Grampians Shire Council (Part) That part east of the line described by the following:- Commencing at Higgins Road, and following the Township of Navarre boundary in a northerly, westerly and southerly direction until the Stawell-Avoca Road is intersected and hence westerly by this road to the Kanya Navarra Road, thence north-westerly by this road to Harcoan Road, thence northerly by this road to Shields Road, thence generally easterly by Shields Road, Katies Road and John Bull Road to Misery Road, thence southerly by this road to McLeod Road, thence easterly by this road to the Ararat-St Arnaud Road, thence north-easterly by this road to the boundary of the township of St Arnaud, thence northerly and easterly by this boundary until it intersects with Brays Road, thence easterly by this road to Old Wedderburn Road, thence north-easterly by this road and Wedderburn Road to the Avoca River.
