## ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION OF BLUEBERRY RUST INTO VICTORIA

I, Keith Hamilton, Minister for Agriculture, make the following Order:

#### 1. Objective

The objective of this Order is to prohibit, subject to conditions, or to restrict the entry or importation of any plant or plant product of *Vaccinium* spp. (including blueberry, cranberry and huckleberry), *Gaylussacia* (black huckleberry), *Rhododendron* spp. (including azalea), *Tsuga* (hemlock), *Lyonia, Menziesia, Pernettya, Hugeria, Pieris, Leucothoe and Oxycoccus* and any agricultural equipment or used package that has been used in association with those species so as to prevent the introduction or spread of blueberry rust (*Pucciniastrum vaccinii*) into Victoria.

#### 2. Authorising provision

This Order is made under section 24 of the Plant Health and Plant Products Act 1995.

## 3. Definition

In this Order -

"agricultural equipment" means any machinery, equipment or vehicle used for propagating, cultivating, harvesting, transporting or marketing blueberry rust host material; "hemlock" means any plant or plant product of the genus *Tsuga*;

"Manager, Plant Standards" means the person for the time being occupying or acting in the position of Manager, Plant Standards in the Department of Natural Resources and Environment;

**"used package"** means any package used for propagating, harvesting, marketing or transporting blueberry rust host material and includes any box, pot, bin, crate, or pallet.

## 4. Controls applying to blueberry rust host material

- (1) The entry or importation into Victoria of
  - (a) any plant or plant product of *Vaccinium* spp. (including blueberry, cranberry and huckleberry), *Gaylussacia*, hemlock, *Rhododendron* (including azalea), *Lyonia*, *Menziesia*, *Pernettya*, *Hugeria*, *Pieris*, *Leucothoe*, *Oxycoccus*; and

(b) any agricultural equipment or used package used in the propagation, cultivation, harvesting, marketing or transporting of host material in sub-clause (1)(a) –

is prohibited unless -

- (c) in the case of
  - (i) fruit of *Vaccinium* spp. (including blueberry, cranberry and huckleberry), the crop:
    - (A) is inspected within 14 days of harvest and no blueberry rust is detected; or
    - (B) is sprayed within 14 days of harvest with a pre-harvest application of a fungicide registered for the treatment of blueberry rust as per label recommendations; and
    - (C) each consignment is packed and consigned free of soil and organic matter; or
  - (ii) agricultural equipment and used packages, the agricultural equipment and used packages have been cleaned free of soil and organic matter and treated by either:
    - (A) steam cleaning; or
    - (B) with a solution containing not less than 100ppm available chlorine used as a spray rinse or dump treatment; or
    - $(C) \qquad \text{in a manner approved by the Manager, Plant Standards; or} \\$
  - (iii) plants of *Vaccinium* spp., each consignment of plants are:
    - (A) approved to be grown in pre or post entry quarantine under conditions to be approved by the Manager, Plant Standards; or
    - (B) grown on a property that is in a State or Territory or part of a State or Territory for which an area freedom certificate for blueberry rust is currently in force; or
  - (iv) other blueberry rust host plants, the plants are inspected within 14 days of dispatch to Victoria and no blueberry rust is detected; and
- (d) the host material in sub-clause (1)(a) is accompanied by a plant health declaration issued by an authorised person, or a plant health certificate issued by an officer of a department responsible for agriculture in the State or Territory in which the host material was grown and packed or where the agricultural equipment and used packages were last used certifying compliance with sub-clauses 1(c) (i), (ii), (iii) (A) and (iv), and a plant health certificate issued by an officer responsible for agriculture in the State or Territory in which the host material was grown certifying compliance with sub-clause (1)(c) (iii) (B).
- (2) Sub-clause (1) does not apply if the host plants (other than Vaccinium spp.) or plant products were grown, or the agricultural equipment or used packages were last used on a property that
  - (a) is located more than 200 kilometres from the detection of blueberry rust; or
  - (b) is located in a State or Territory or part of a State or Territory for which an area freedom certificate issued by an officer responsible for agriculture in the State or Territory where the plant and plant product was grown or the agricultural equipment or used packages were last used is currently in force certifying that the State or Territory or part of the State or Territory is known to be free of blueberry rust.

Note: Section 25 of the Act provides that a person is guilty of an offence and a penalty not exceeding 200 penalty units for knowingly breaching an Importation Order

## ORDER DECLARING A RESTRICTED AREA AT WANGARATTA FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Keith Hamilton, Minister for Agriculture, under sections 20 and 22 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of Queensland fruit fly at Wangaratta and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

## 1. Objective

The objective of this Order is to declare a restricted area for the control of Queensland fruit fly at Wangaratta and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

## 2. Authorising provisions

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

## 3. Definitions

In this Order-

- (a) "Act" means the Plant Health and Plant Products Act 1995; and
- (b) "Queensland fruit fly" means the exotic pest *Bactrocera tryoni* (Froggart); and
- (c) "Regulations" mean the Plant Health and Plant Products Regulations 1996.

## 4. Restricted area for the control of Queensland fruit fly

The restricted area for the control of Queensland fruit fly is declared to be the areas described in Schedules 1 and 2.

## 5. Prohibitions, restrictions and requirements

- The removal from the restricted area into any part of Victoria of any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations is prohibited unless the fruit or vegetable is accompanied by a Plant Health Certificate or Plant Health Declaration and in the case of fruit for treatment, packing or processing outside the restricted area, is accompanied by a permit issued by an inspector under section 21 of the Act.
- (2) The owners and occupiers of land described in Schedule 2 must give access to such land at all times to an inspector, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspecting, placing on such land any lures or traps, applying on such land any spray material or bait and performing any other actions which in the opinion of the inspector are necessary for the eradication or prevention or spread of the pest.
- (3) The owners and occupiers of land described in Schedule 2, on instructions from an inspector, must strip fruit from trees, collect and dispose of waste fruit, or treat fruit and vegetables listed as hosts of Queensland fruit fly in Schedule 5 of the Regulations in a manner approved by the Secretary.
- (4) Any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations which is transported through the restricted area, from areas free of Queensland fruit fly, must be transported in accordance with the conditions of a permit issued by an inspector under section 21 of the Act.

#### **Livestock Disease Control Act 1994**

ORDER DECLARING A CONTROL AREA FOR BOVINE JOHNE'S DISEASE AND SPECIFYING PROHIBITIONS ON ENTRY OF SUSCEPTIBLE LIVESTOCK INTO VICTORIA

The Governor in Council makes the following Order:

#### 1. Objective

The objective of this Order is to -

- (a) revoke the Order declaring a control area for bovine Johne's disease and declaring prohibitions on entry of livestock into Victoria made on 21 March 2000; and
- (b) declare the whole of Victoria as a control area for bovine Johne's disease; and
- (c) specify requirements which are to operate in the control area; and
- (d) prohibit the entry of cattle and goats into the control area under specified circumstances.

#### 2. Authorising Provision

This Order is made under section 6 of the Livestock Disease Control Act 1994.

#### 3. Revocation

The Order declaring a control area for bovine Johne's disease and declaring prohibitions on entry of livestock into Victoria made by the Governor in Council on 21 March 2000 and published in the Government Gazette No. G12 on 23 March 2000 at page 527 is revoked.

#### 4. Definitions

In this Order -

**"approved eradication program"** means a program which has been approved by the Manager, Animal Health Operations, Department of Natural Resources and Environment to eradicate *Mycobacterium paratuberculosis* from infected herds;

**"approved feedlot"** means a premises for the fattening of cattle that is approved by the Manager, Animal Health Operations, Department of Natural Resources and Environment;

**"approved market assurance program"** means a program of herd testing approved by the Manager Animal Health Operations, Department of Natural Resources and Environment to provide assurance with respect to bovine Johne's disease;

**"bovine Johne's disease"** means infection with cattle strain(s) of the organism *Mycobacterium paratuberculosis*;

"susceptible livestock" means cattle and goats;

"the Act" means the Livestock Disease Control Act 1994;

"the Flinders Municipality" means the islands of the Furneaux group located off the north east coast of Tasmania.

#### 5. Control Area

The whole of Victoria is declared to be a control area in respect of bovine Johne's disease in relation to susceptible livestock.

#### 6. Requirements in the Control Area

An owner of any susceptible livestock within the control area must –

- (a) submit the susceptible livestock for testing and sampling for bovine Johne's disease in accordance with any directions that may be issued by the Manager, Animal Health Operations of the Department of Natural Resources and Environment, to a registered veterinary surgeon, an Inspector of Livestock or a person authorised by the Manager, Animal Health Operations of the Department of Natural Resources and Environment to test and sample susceptible livestock for bovine Johne's disease; and
- (b) provide adequate facilities and sufficient assistance to allow the safe and efficient handling of the susceptible livestock during the sampling and testing procedures required under paragraph (a); and
- (c) provide information on the movement of susceptible livestock onto and from the property to an Inspector of Livestock upon request.

#### 7. Prohibition on entry

For the purposes of preventing the entry into Victoria of bovine Johne's disease, the entry into the control area of any susceptible livestock –

- (a) which originates or comes from a property where
  - (i) infection with cattle strain(s) of *Mycobacterium paratuberculosis* in any susceptible livestock has been diagnosed; and
  - (ii) an approved eradication program applying in the State of which the property is part to eradicate *Mycobacterium paratuberculosis* infection, has not been completed –

is prohibited except in accordance with a licence or authority issued under section 10(4) of the Act.

- (b) which originates or comes from a property located in Tasmania, other than the Flinders Municipality, is prohibited unless
  - (i) the susceptible livestock are to be transported directly to an abattoir for slaughter; or
  - (ii) the susceptible livestock are to be placed on an approved feedlot in the control area for fattening and subsequent direct movement for slaughter; or
  - (iii) the susceptible livestock originate from a herd with a status of Monitored Negative or Check tested under an approved market assurance program; or

- (iv) the susceptible stock originate from a herd with current registration in the Beef Cattle Trade Assurance Scheme; or
- (v) the susceptible livestock are steers that originate from a non-assessed herd; or
- (vi) entry is in accordance with a licence or authority issued under section 10(4) of the Act –

and the susceptible livestock are accompanied by a declaration to that effect signed by the owner or the person in charge of the susceptible livestock.

#### **Vocational Education and Training Act 1990**

CHISHOLM INSTITUTE OF TECHNICAL AND FURTHER EDUCATION ORDER 2002 The Governor in Council makes the following order:

#### 1. Objective

The objective of this Order is to abolish the TAFE College called the Chisholm Institute of Technical and Further Education and to create a new TAFE College to be called the "Chisholm Institute of Technical and Further Education".

#### 2. Authorising provision

This Order is made under section 23(1) of the **Vocational Education and Training Act 1990** on the recommendation of the Minister for Education and Training made in accordance with that section.

#### 3. Commencement

This Order takes effect on the date the Governor in Council makes the Order.

- 4. Abolition of the former Institute and creation of Chisholm Institute of Technical and Further Education
  - (1) The Former Institute is abolished.
  - (2) A TAFE College called the "Chisholm Institute of Technical and Further Education" is created.
  - (3) Pursuant to section 23(1)(g) of the **Vocational Education and Training Act 1990** the Governor in Council may amend Schedule 1 by changing the name of a TAFE College. Schedule 1 to the **Vocational Education and Training Act 1990** is amended
    - (i) by **removing** "Chisholm Institute of Technical and Further Education"; and
    - (ii) by **inserting** "Chisholm Institute of Technical and Further Education".
