1. Title

These Regulations may be cited as the Melbourne Parks and Gardens (Joint Trustee Reserves) (Amendment) Regulations 2002.

2. Objective

The objective of these Regulations is to increase the daily charge per person to the Melbourne International Flower and Garden Show from a maximum of \$15.00 to \$17.00.

3. Authorising provision

The Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

4. Commencement provision

These Regulations come into operation on the day that they are published in the Government Gazette.

5. Increase in maximum charges for entry to Carlton Gardens

In Regulation 19 [2] to the Melbourne Parks and Gardens (Joint Trustee Reserves) Regulations 1994, after the word "exceeding" delete the expression "\$15.00" and insert the expression "\$17.00."
