By this notice, the Victorian Casino and Gaming Authority **amends** the Rules in respect of the game "Craps"<sup>1</sup> as set out in the Schedule.

# Amendment to rules for Craps

For rule 9.3, substitute —

- "9.3 A single dealer shall be positioned behind the float and shall control the dice. This dealer shall be responsible for all payouts and the operation of the game.
  - 9.3.1 The dealer will use either a stick, designated for the purpose or his/her upturned palm to retrieve and/or pass the dice to the shooter.
  - 9.3.2 A boxperson may, at a Casino Supervisor's discretion, assume the stickperson's responsibilities thus making Mini Craps a two-person game. The boxperson shall be positioned opposite the dealer when acting as the stickperson."

### **Amendment of Rules**

1. In rule 1.1 at the definition of "game hardware" substitute—

""game hardware" means all the computer equipment needed for the conduct of the game, including one or more ATSs, an SCG, and routing, networking and communications devices and cabling;".

- 2. After rule 8.9 insert
  - "8.10 If during a round of play an error occurs that is not disclosed until after the commencement of a subsequent round of play, that error will not have any effect on the outcome of subsequent rounds of play.".

# Amendment of rules

1. For rule 36.1.7, substitute—

- "36.1.7 "tournament director" means the General Manager Gaming Machine Operations or designee, who shall be responsible for the conduct of a tournament in accordance with the prescribed conditions of play.".
- 2. For rule 36.3.10, substitute—
  - "36.3.10 Any credits and/or coins remaining at the completion of a session will be either played off, cashed out and retained by the player or remain the property of Crown as stated in the conditions of play.".
- 3. For rule 36.4.2, substitute—
  - "36.4.2 A player may wager up to the gaming machine maximum available bet.".
- 4. For rule 36.5.2, substitute—
  - "36.5.2 In the event that at the completion of a session, all players have neither credits nor coin remaining, the winner and subsequent placegetters will be determined by the order in which they complete their credits ie, the winner will be the player who completes their credits last and subsequent placegetters will be awarded accordingly.".
