Notice of Amendment & Draft Permit

Amendment C16

Draft Permit No. 01735

The Frankston City Council has prepared Amendment C16 to the Frankston Planning Scheme and draft permit No. 01735.

The Amendment and draft permit affect land at 286 Frankston–Flinders Road, Frankston South. The Amendment proposes to increase the floor area limits for this site to allow up to 130 square metres more office floor space and up to 340 square metres more shop floor space.

The Amendment and permit allow the use of an existing building for an office and the construction and use of a new building in the south eastern part of the site for equestrian supplies. The draft permit conditions address a variety of amenity issues, require the owners to enter into a legal agreement limiting use of the new building to restricted retail premises and allow a reduction in standard car parking rates.
