

Pipelines Act 1967

NOTICE UNDER SECTION 11 OF THE PIPELINES ACT 1967 (VIC)

Application for a Permit to Own and Use A Pipeline 247

- 1. In accordance with the provisions of Section 11 of the **Pipelines Act 1967** (Vic), notice is given that an application has been received from DEI Vic Hub Pty Ltd (DEI) for a Permit to Own and Use a Pipeline for the purpose of conveying gaseous hydrocarbons between DEI Longford Compressor Station to GasNet Australia (Operations) Pty Ltd Longford Metering Station.
- 2. For this particular application, the Victorian Minister for Planning determined that DEI should prepare an Environmental Report (ER). The ER is to draw upon previous environmental assessments for the Tasmanian Natural Gas Pipeline and the Eastern Gas Pipeline projects. Both projects underwent a joint Commonwealth/State public hearing assessment process. Details of the pipeline permit application and the ER may be viewed at those locations listed in point 4 of this Notice.
- 3. The proposed route of the pipeline is generally as shown on the map below and described below:



A steel pipeline approximately 2.2 kms in length with a nominal bore of 350 mm, situated in an existing 30m pipeline easement, and commencing at the DEI Longford Compressor Station and terminating at the GasNet Australia (Operations) Pty Ltd Longford Metering Station.

4. The above plan is only indicative and detailed plans of the proposed route of the pipeline may be inspected between the hours of 9.00am and 4.00pm Mondays to Fridays (excluding
